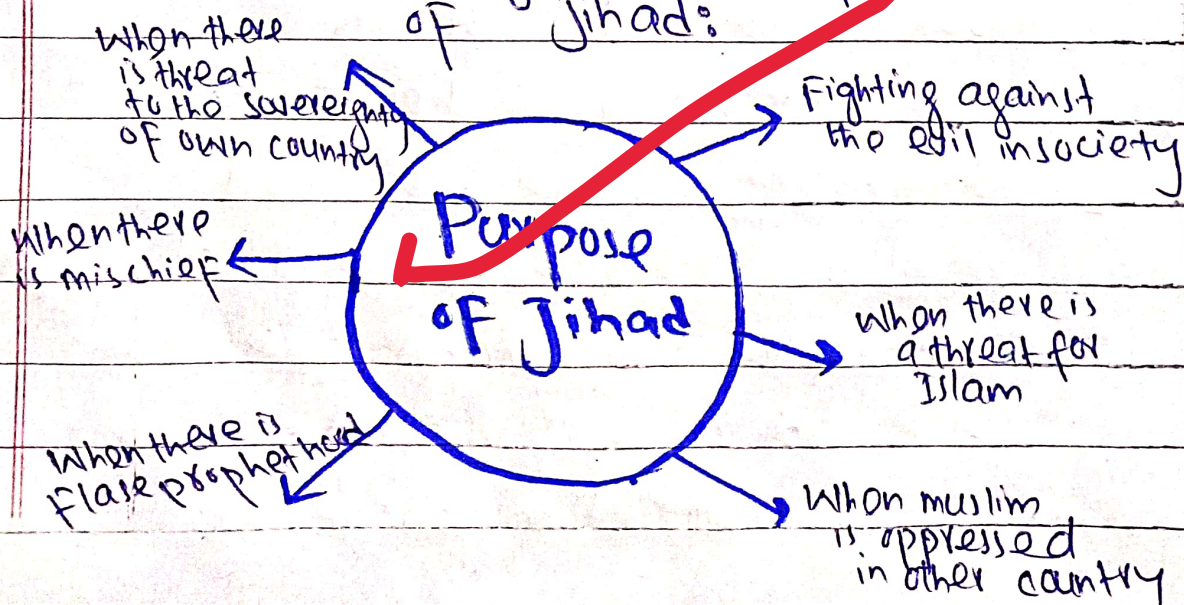

Badr, Uhud, etc.

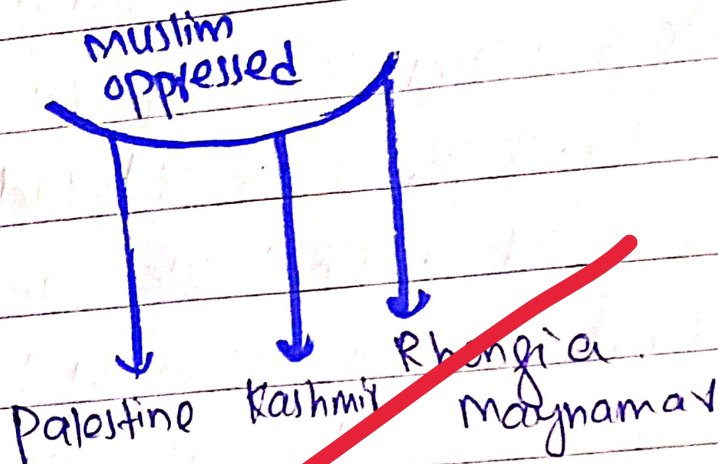
