① INTRODUCTION

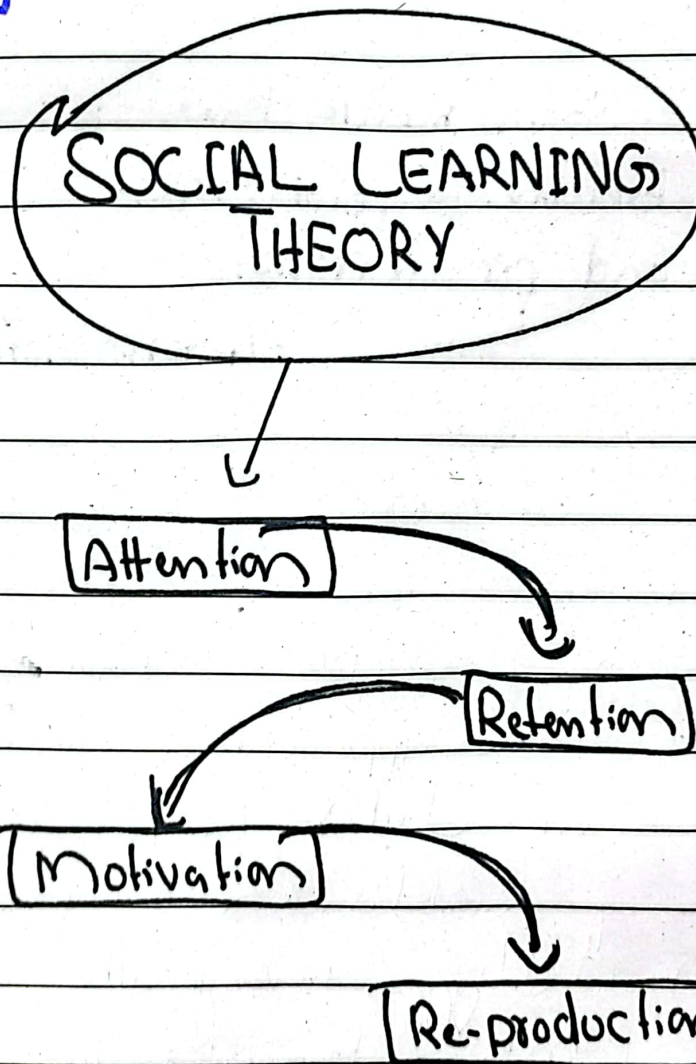
Social media has become a fertile ground for terrorists
