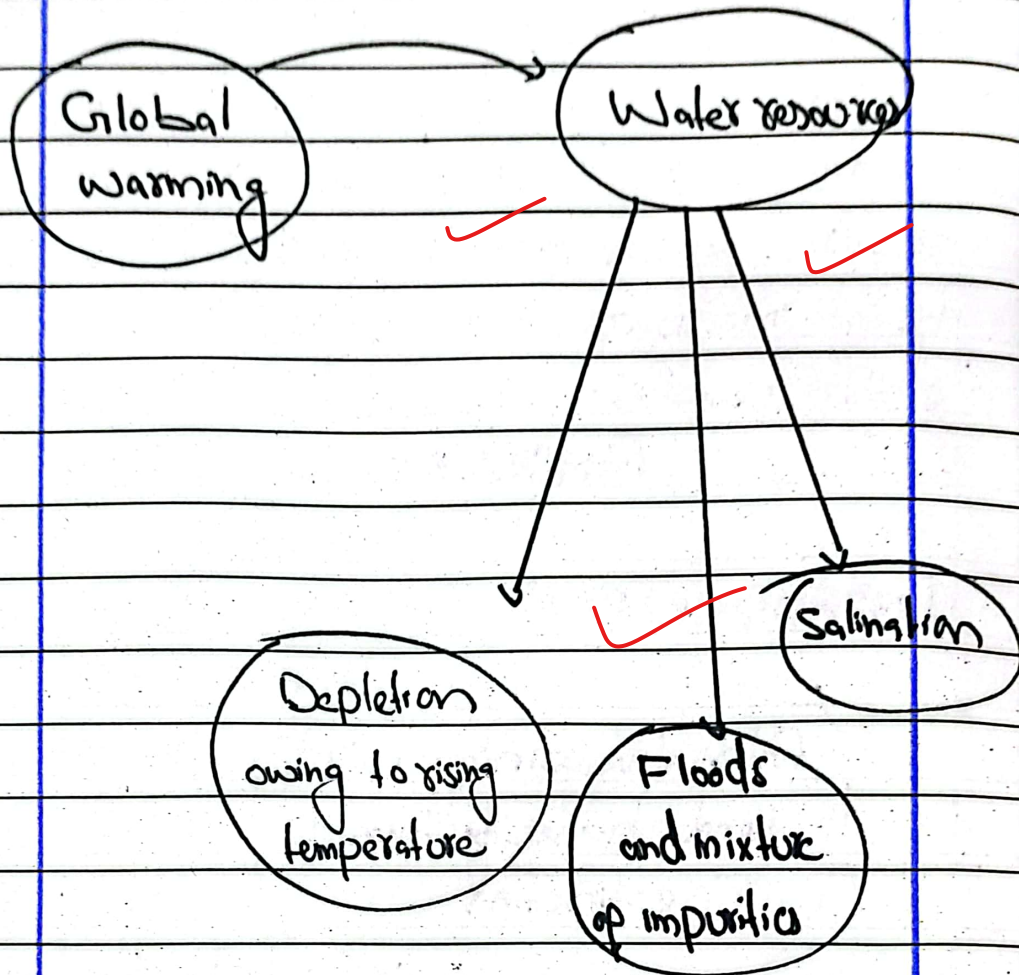
① INTRODUCTION

2.4. Rising salination issue - merging of fresh water with sea water

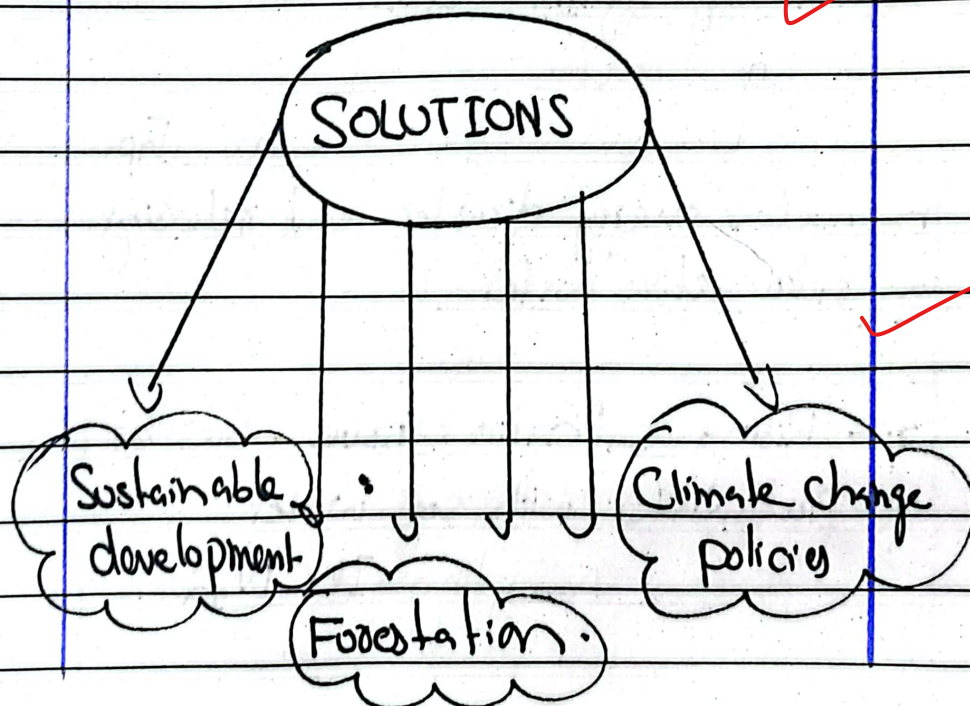
According IUCN, 2001,

According to COP-26 and 27 no single country achieved 'net zero' target that was ensured in the Paris-agreement.

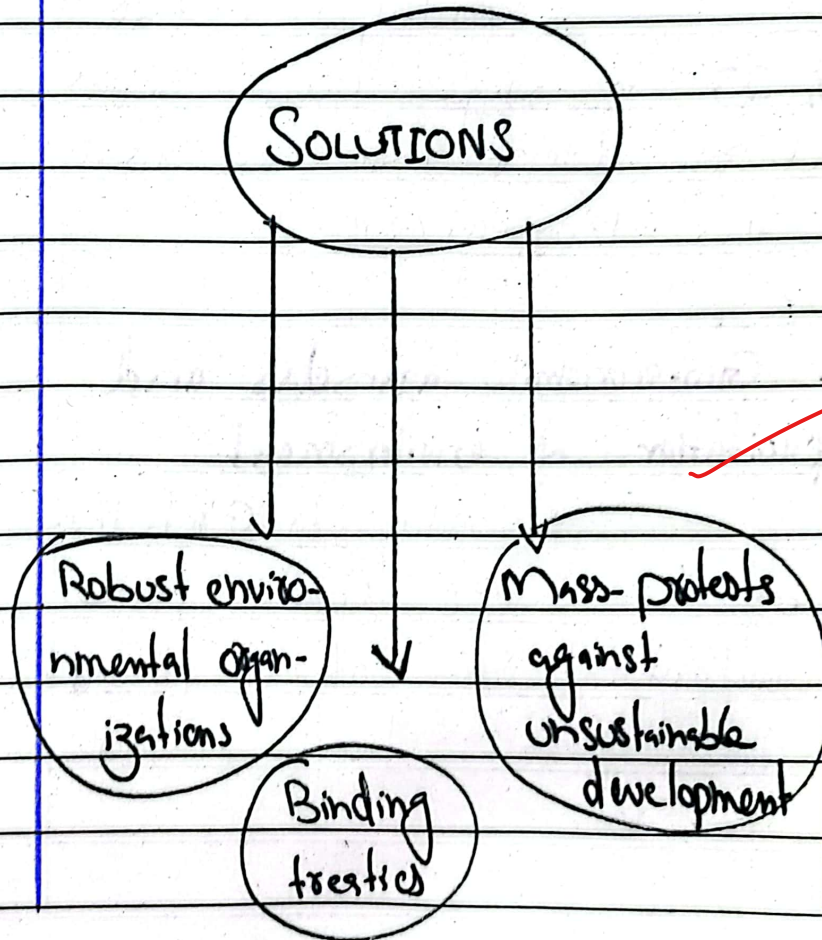

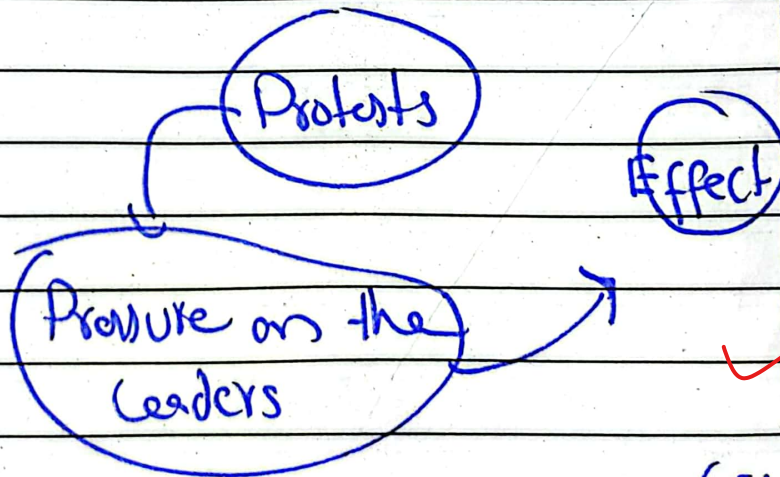
2.1- Robust environmental organizations
