of Criminology in detail

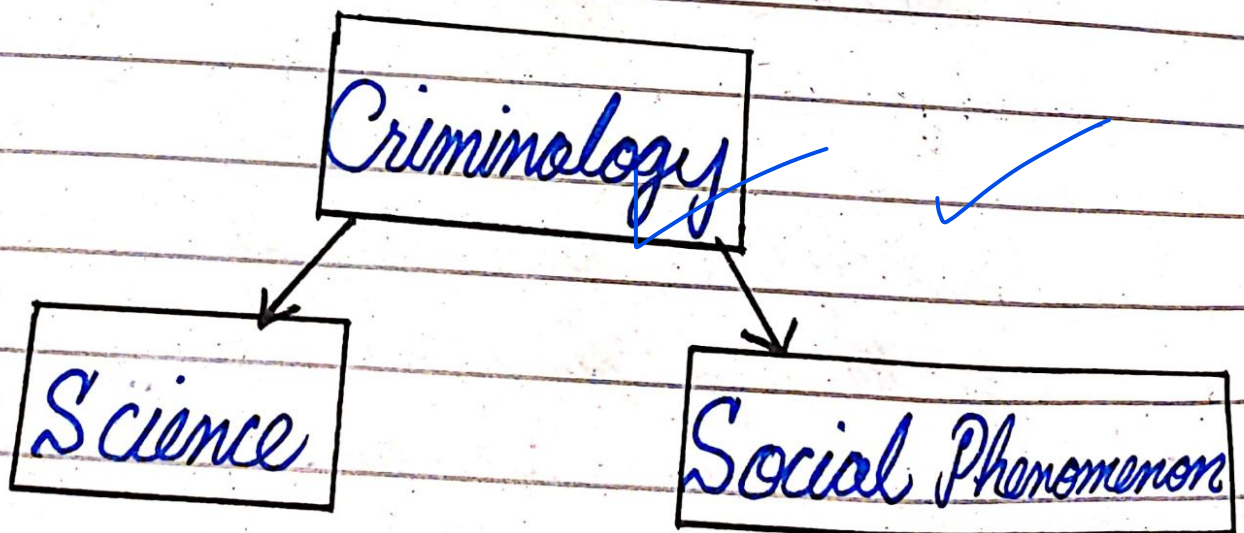
1. Introduction:

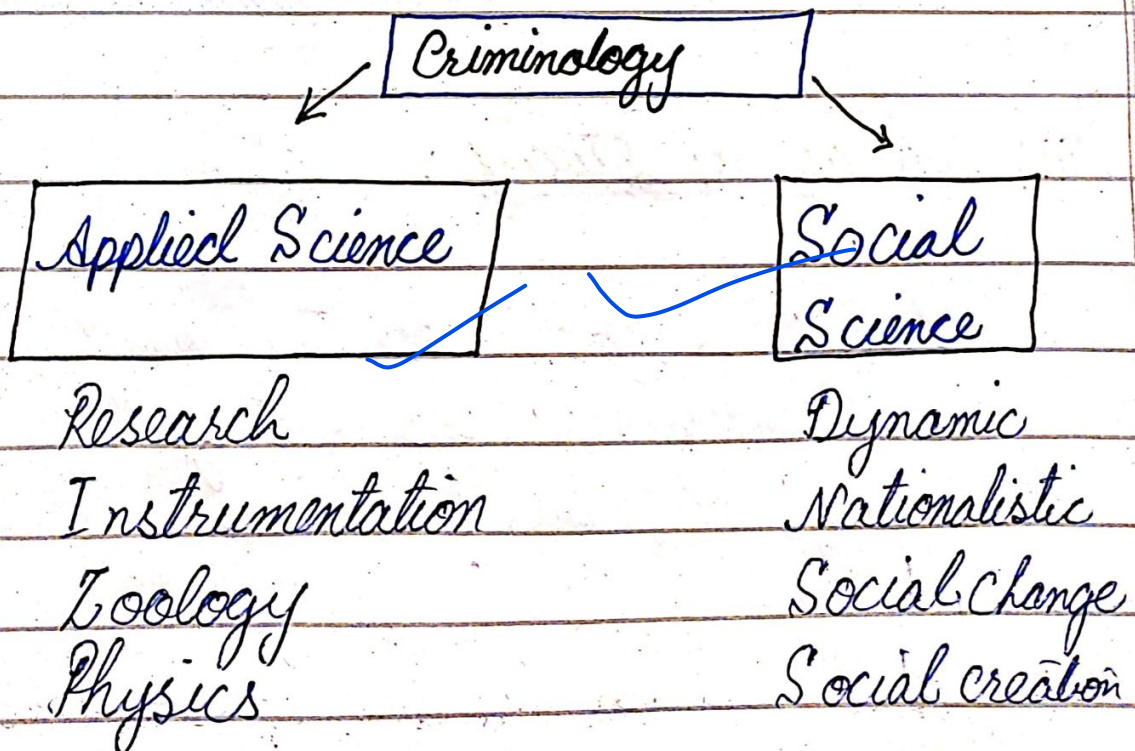

3. Nature of Criminology:

(i) Criminology as a Science :

Criminology is a science in itself when applied to law enforcement and prevention of crimes. It also deals with scientific evidences and scientific behaviors in detection of crimes. Besides this, scientific research is another extensive field of criminology including forensic science.



ii) Criminology VS Crime detection :

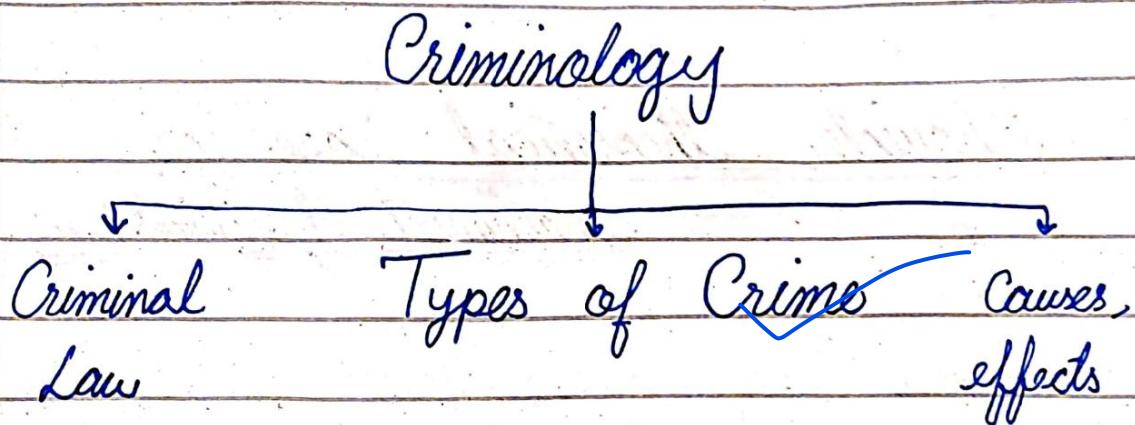
Criminology should not be confused with the science of criminal detection or forensic science and forensic pathology. There is no direct connection between the study of crimes and detection of crimes. Criminologists are more concerned with why and how crimes are committed.

iii) Areas of study :

is not actually criminal. It throws light on the gaps in criminal law. Studies of alcoholism, drug abuse, gambling and sexual behavior are included in this examples.
