### ① Introduction

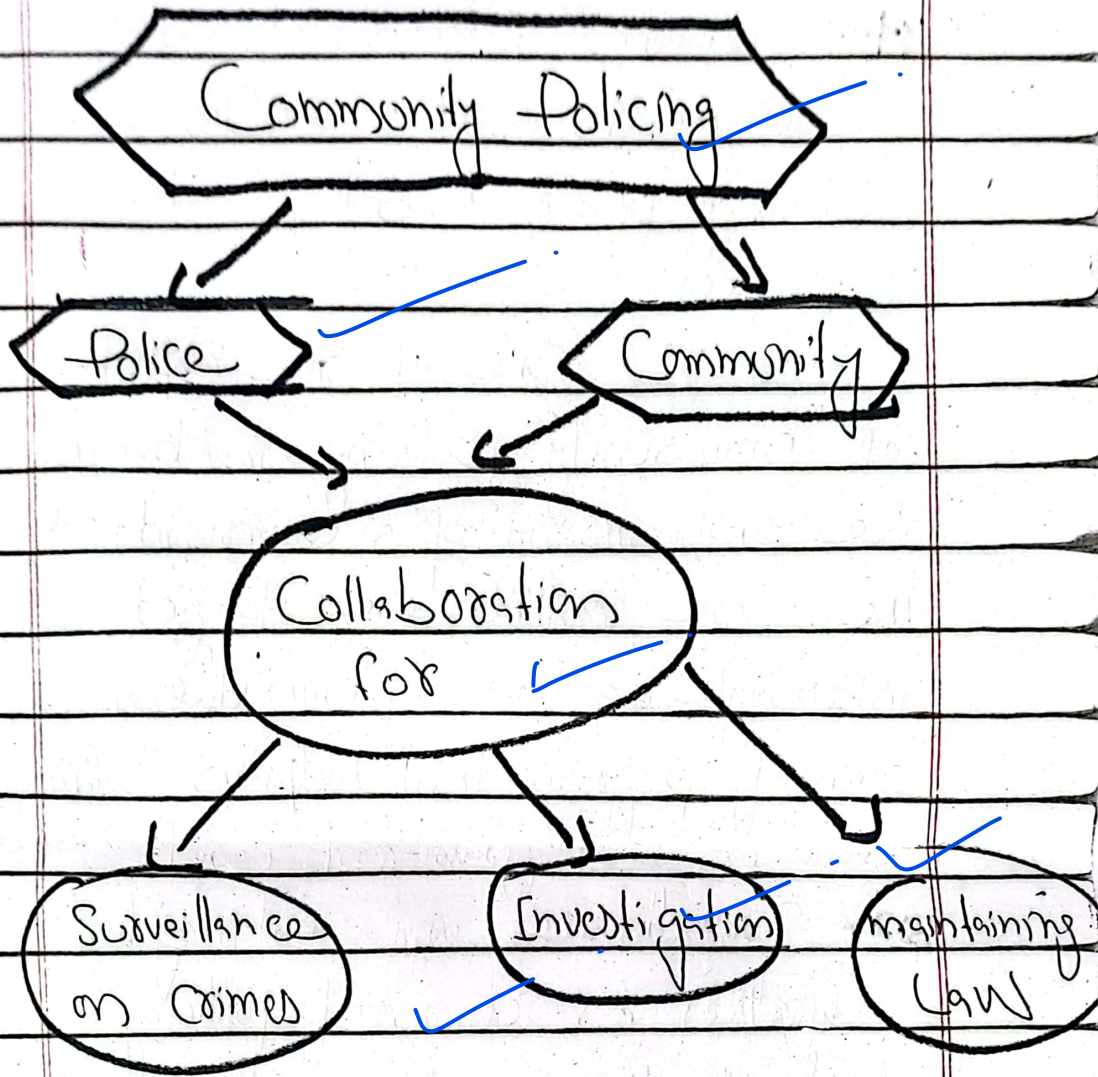
