Geopolitical dynamics encompass the power struggles and the alliances between nations, where the actions of superpowers and regional players wield immense influence. Socio-economic dynamics delineate disparities in wealth, access to resources and development, often catalyzing tensions and conflicts, while fostering cooperations and stability in more equitable circumstances. Ideological dynamics, driven by diverse belief systems, political ideologies, and cultural values, contribute both unity and discord among nations. These dynamics, further complicated by technological advancement and transnational challenges further complicated by technological advancements and transnational challenges like climate change and pandemics, continually shape the global landscape, creating a delicate equilibrium between cooperation and contention, progress and regression, ultimately defining the trajectory of world peace.

This trajectory of world peace is heavily influenced by the power and might of super powers on the world stage. This gives them the power to choose between a world of peace or a world driven by tensions. This is being discussed in the following paragraphs that how the super powers influence the world peace.

The world superpower countries wield substantial control over global economic resources. This control over economic resources allow them to

to leverage trade negotiations and leverage loan agreements for other nations, and them selves, this leads to conflicts and causes inequality. According to the world bank report of 2023, economic inequality within countries correlates with increased risk of conflict. This is further supported by Karl Marx theory of conflict according to which conflict is sparked due to fight competition for resources. This shows how the superpowers with a combined global GDP of 45% can influence the decisions of other countries and overall impact global peace.

Furthermore, The United Nations developed to foster peace around the world, is its most powerful body the United Nations Security Council is hampered by the veto power. The five permanent members US, China, Russia and France having the veto power can easily stop any resolution to pass thus creating an obstacle for peace. This is evident from the recently vetoed resolutions for ceasefire in Gaza by the United States. This further highlights the fact that "world peace" is choice of super powers.

Secondly, Super powers pursuit for world hegemony breeds proxy conflict. As the Super power chooses to be world hegemon, their pursuit of hegemony distorts peace around the world. The ongoing conflict was evident in the cold war period, the competition between US and USSR saw numerous proxy conflicts that destabilizing regions like central America and Africa. This shows us that how the pursuit of hegemony by superpowers raises conflicts and chaos around the world.

Thirdly, treaties are developed to establish peace around the world. However these treaties are based on the will of superpowers and there is no one to enforce them on the superpowers, therefore if superpowers wants peace will prevail otherwise they will withdraw from the treaty.

Recently Russia's withdrawal from Intermediate-Range Nuclear Force treaty raises concerns about arms race escalation and increased potential for nuclear conflict. This highlights the influence of superpowers on treaties and the treaties inefficiency in maintaining world peace.

Fourthly, superpowers have the ability to intervene in autonomous policy formulation towards collaborative diplomacy.

~~The shows how~~ therefore superpowers can influence not only global policies but also regional policies through which global peace can be effected. For instance the G7 and G20 summits, dominated by superpowers, set the agenda for global issues like climate change and economic regulation. This

can be used to by the superpowers to direct the trajectory of world peace. A Along this

a 2021 report by the Global Centre for the responsibility to protect argues that superpowers interests can hinder effective responses to human rights abuses and humanitarian crises. It is

this ~~that~~ ~~has~~ interests that cannot stop the genocide happening in Gaza. Therefore the world is a playground for the superpowers where other countries place for their choices and peace becomes their choice.

On the other side of the argument, it also can be said that despite the major roles of superpowers in maintaining global peace. Sovereign nations and regional blocs along different organizations can contribute toward ~~(the world peace)~~ maintain world peace.

First of all, Regional blocs and organizations like the World Trade Organization (WTO) provides an alternative economic pathway. Regional blocs allow countries to trade within and decrease their dependence on the world's superpowers to trade. As Pakistan recently performed a better trade with its neighboring countries, this allowed the country not to depend on US dollars for trade but to use alternatives. Such measures between different countries such as India and Russia trade in Yuan (¥) gives regional countries freedom of trade and simultaneously reduce the prominence of superpowers on the world stage. Therefore if the right initiatives are taken it wouldn't be superpowers to decide or opt for peace but the contribution of the entire world.

Furthermore, The UN peacekeeping army operates ~~(without)~~ independently for maintaining peace. The UN peacekeeping army is contributed to by all the member countries as 120 nations contribute military personals to the country army hence decreasing the reliance on superpower force for conflict resolution.

army had played a pivotal role in protecting civilians and promoting dialogue in conflict zones. This shows that peace can be achieved in the world without the help and contribution of superpowers.

Secondly, Conflicts within and between superpowers limit their effectiveness in maintaining world peace. As superpowers face internal conflicts their diplomatic efforts to maintain peace and diplomatic supremacy starts getting questioned on the basis that 'how can a country with internal disputes, resolve disputes of other countries. The ongoing war in Ukraine exposes the potential for internal conflicts within superpowers to destabilise global security and disrupt diplomatic efforts. This collectively shows that conflicts around the superpowers limit their choice to decide on world peace but shall address and bring peace internally first.

Thirdly, The international treaties reflect collective efforts for peace. If the treaties were only by the superpowers then they would be the sole signatory of the treaties. However that is not the case the treaties are joined by many countries to bring peace in the world, for instance if the nuclear non proliferation treaty was signed only by the superpowers then other nations would have not given up their nukes and the proliferation race would have still

been going on. This highlights the fact that (that) world peace is not only the choice of superpowers but also the collective choice of the entire world.

Fourthly, Regional autonomy allows for tailored policies, fostering independence from superpower interference.

The different countries of the world and different regional blocs tailor their own policies that contribute to global peace building these policies are their sole decisions and not interferences of superpowers. For instance countries like Costa Rica and Norway demonstrates the effectiveness of localized peacebuilding initiatives in resolving conflicts and maintaining stability. Furthermore countries like UAE and other oil producing have taken initiatives to diversify their economies from oil production to other income earning ways so that sustainable development can be fostered and issues like climate change can be addressed. It showcasing the contribution of other countries in maintaining peace and sustainability.

However there are contribution of other nations in maintaining peace, and but the role of superpowers is can not be ignored. As a matter of fact the contributions of these nations is negligible and doesn't have domino affect on the world peace but the strategies and actions of super powers is observable and sends shockwaves throughout the world making world peace limited to their own choices.

For instance, regional blocs and organization can complement but can not eliminate the dominance of superpowers in economic dealings. The superpowers like USA and China has a 35% of global GDP share and any economic policy they adopt has effects around the world. In the wake of Covid-19 pandemic as China closed its exports the entire world started suffering from shortages in every department, thus bringing instabilities and inflation in every country. Therefore the world's direction and stability depends on the actions of superpowers.

Secondly, the UN Peacekeeping army although contributed by 120 countries is heavily influenced by superpowers. As the superpower countries have veto capabilities they influence UN peacekeeping mission this can also be seen in the recent Ukraine and Gaza crisis. In the Ukraine issue Russia vetoed UN interference and the Gaza crisis so a veto from the United States. This shows the influence of superpowers in international organizations.

Furthermore, superpower conflicts do limit diplomatic efficacy but the global conflict resolution strategies are influenced by superpowers. For instance the tensions between US and China over Taiwan and semiconductor illustrates rivalries between superpowers, demonstrating how superpower

Competition can undermine diplomacy and lead to widespread instability. However, still the role of China and US in shaping global dynamics is evident from China's effort in rapprochement of ~~UAE~~ Saudi Arabia and IRAN, who had ~~it~~ ^{had} decades long rivalry. This ultimately shows that the global conflict resolution strategies are shaped by superpowers.

Thirdly, International treaties are imposed by superpowers. Although treaties do face challenges from nations like South Korea and Iran the superpowers for the sake of building peace puts sanctions to impose, treaties on countries. This is evident from the case of IRAN, with the presence of nuclear arms US and ON lead sanctions on the country made it to rethink developing nuclear weapons. This overall shows how the efforts of superpowers can influence global peace.

Fourthly, Global peace can be attained by ~~balancing~~ balancing regional independence along superpowers involvement. The regional autonomy fosters localized peace initiatives but superpower involvement often shapes collaborative diplomatic efforts, balancing regional independence with global cooperation for sustained peace.

To sum up the entire above discussion we can say that global peace is not only the choice of super powers, but as the actions and ~~anti~~ strategies of other nations also have

an impact on the peace of world. However
as the superpowers are always on the
spotlight on the global stage and
they have the resources along the
capacity to majority influence the
decisions taken around the world.

circumstances and how their actions
unfolds.
