

Question: Pakistan Resolution of 1940 is termed as Magna Carta of Pakistan Movement. Elucidate.

→ Introduction:

The historical passing of Pakistan resolution in 1940 is regarded as an integral part of Pakistan movement which was successful in transcribing a separate status to Muslims. This achievement of objective presents an enormous similarity with Magna Carta of 1215 that was primarily based on devolution of power and stating that law is above all. Hence, on the terms of bearing resemblance the Lahore Resolution can be compared to Magna Carta of Pakistan Movement.

→ Pakistan Resolution of 1940 as Magna Carta of Pakistan Movement:

(i) Pakistan Resolution was able to legitimise the All India Muslim League Demand:

Pakistan Resolution of 1940 was

successful in providing a formal platform for the politically articulated two-nation theory. It was now an official demand of Indian Muslims presented by their representative organisation to counter demand of Indian National Congress of a united India after Britians left.

(ii) Pakistan Resolution provided a vision and roadmap:

Like Magna Carta, Pakistan Resolution was able to provide a guiding vision and framework for the leaders to carry on with. According to Stanley Wolpert, this moment earmarked the transition of Jinnah from Hindu-Muslim ambassador to Quaid-e-Azam.

(iii) Pakistan Resolution was able to propagate the idea of seperate homeland for Muslim minorities.

Pakistan Resolution was initially named as Lahore Resolution.

but the growing influence of this historical movement was a pressurised the hindu media to spread the use of word Pakistan. Indirectly Resolution the Lahore Resolution was able to ~~cope~~ capitalise to ~~capitalize~~ this opportunity to spread the name for separate homeland. Thus, like Magna Carta, this resolution was able to cater minorities and negate concentration of power.

(iv) The text of Resolution resisted the concentration of power:

Pakistan Resolution clearly rejected the presence of the Federal system under Government of India Act 1935. In this ~~policy~~ The proclaimed absentionation of Muslim leaders from accepting Federal sys Government of India Act 1935 was solely based on the reason to secure equal representation for Muslim. Thus, similar to Magna Carta, Pakistan Resolution was

able to stand firm against the exploitation of law by the apparent kings "Hindus and Britishers" of Subcontinent of that time.

(v) Pakistan Resolution ensured the inclusivity of minority Muslims:

Pakistan Resolution ~~is~~ explicitly mentioned in the text that no amendment in constitution or revision in constitutional plan would be acceptable unless the inclusivity of Muslims is ensured. This act was done to safeguard the manoeuvring of rights of minority by the majority party of that time. Hence, Resolution was able to protect the minority as seen through the enactment of Magna Carta.

(vi) Pakistan Resolution demanded equal sovereignty and autonomous position for Muslims:

Pakistan ~~was~~ Resolution was able

to demand for equity in autonomous
 Sovereignty for the Muslim minorities
 For this purpose it demanded the
 land with geographical congruity to
 be gathered into a separate homeland.
 This unequivocal demand for
 Sovereignty and autonomy of
 Muslim minorities speaks volume for
 the similarity it possess with Magna
 Carta demanding equality for Barons
 against king of that time.
