there are proper laws and acts presented.

Likewise there is a law for child labor that <sup>protects</sup> shows the rights of

children. Article 11(3) of Pakistan constitution

expressly prohibits the employment of child labor below the age of fourteen

year in any factory, mine or other hazardous employment." But the

weakness of the law enforcement

institution causes the more heinous

crime of child labor. As a result

the criminal negligence is becoming higher day by day.

In Pakistan, the elite class is controlling all the law enforcement institutions which means, any crime which the elite class would commit it will easily be ignored by these institutions. For example "Tayyaba case in 2016" It states the child labour and the abuse which session judge Raja Khurram and his wife did on a 10 year old girl. The child abuse penalty is life imprisonment and the minimum 10 year in prison but they both came back from jail after only one year. Therefore the child labor remain prevailed in country if the elites are released without completing their penalty.

The major cause of this elite favouritism is the corruption and the bribery. These law enforcement

Institutions which are front line safeguards of public are indulged in these crimes, what ~~to~~ these people would expect from them to provide them the protection from any abuse. For example "According to Corruption perception index Pakistan Scores 27 out of 140 in the year 2022". Because of this higher rate of corruption the law could not be enforced and the children could not get protection.

Police the front line protection giver body of any country. But unfortunately, this institution also lacks activeness in its performance. In the inner city areas where there is high populated area, the police could not keep eye on the abuses and labor of children with less consideration. For

example, In inner Karachi, the rate of crime is high and the child labour in these areas could easily be presented because there is not the effectiveness of police. Resultantly, the crime rate and child labour is high in the rural as well as in the urban areas of inner part.

At the beginning of something, the performance is on the peak, but when the time passes, the performance becomes slow down. Like wise at the creation of the Non-Governmental Organizations, these work tremendously high but after some time it slows down. There were many NGOs which worked up to the mark but after time passed, their performance became slow down. There must be a proper consideration in this regard that would do something in eradicating

Furthermore, the political stability directly links with the child labour prevention. Because the stability in the politics means the strengthening of its institution that made the law enforcement in the country. Resultantly, the child labour becomes at its lower rate. But in Pakistan, the dilemma is that the politics is not stable in from since many years. And the law enforcement agency including all the institutions are in uncertainty. If there commit a crime, the process of justice becomes so slow that even the urtime becomes heated. For example, from the past, the constitution making process than the Marshal laws, then the military intervention etc are were the hurdles in the political stability.

The consequences of criminal neglect of child labour are immense in number.

The first and foremost is the child abuse. This cause further problems and consequently, the children suffer from immense problems. The owners of the related factory of child labour center, abuse the children, beat them, sexually harm them and do what they want. According to a report in 2019 employers engaged in child labour and child domestic work (CWD), are between 10 and 15 years of age". Furthermore In 2022, a total 4253 cases of child abuse were reported. (Wikipedia.com) This states that the child labour consequences of the child abuse that leads to further problems.

By When there is negligence

of criminal justice system in any country, there are higher possibility of the crimes high rates and likewise the child labour which humiliate the children sentiment and consequently they become indulged in the criminal activities like drug abuse, thefting, smuggling and even in terrorist activities for money. This would harm the country's social, economic and even cultural structure. There prevails the criminals in small areas of any city that could easily commit crimes.
