

It is reported that around 8000 women die each year with several thousands injured from "kitchen fives", primarily in Pakistan, Bangladesh and India (Rights Universal Bride Burning, April 2017) in such cases, wife is typically doused with petrol and set on five one of the reasons is also associated with downy where a women's worth is the amount of downy she brought with her many incidents are reported where girls and sometimes their pavents are targeted for not sending "things that only her daughter will use".
