Growing economic disparities and unequal distribution of wealth led people to suffrage movements and most of them were become extremist and react violently.

According to the book "What is behind the rise of ISIS" by "Jim Tankersley" in his book "high concentration of wealth in few hands and war waged by the west and middle-east led to frustration and enhanced extremism. As a result, In Yemen a tribe "Houthis" were marginalized in which the Houthis were neglected

The area is oil rich, The funds were not equally distributed, in that case they become extremist for oil generated wealth distribution and gaining economic disparities. Hate speech rises to religious extremism between shia and sunni after the collapse of ottomans empire the middle-East become the battle ground for the shia sunni rivalry. Whereas, the Shia were supported by the Iranian and the sunni were by kingdom of Saudi Arabia (KSA). Hence, the major conflict arises by the sectarianism and the role played by the religious clerics against each other set which cause the religious polarization. According to the book "The Future of Polarization by Stephen P. Cohen." in his book illustrated that "Hate speech has mostly risen by the religious

Clerics other than the people or individuals. Because that speech spread hate factor among the masses.

The rise of Hindutva "Akaad Baharat" modi facism let indian marginalized people into the critical situations.

Rising religious extremism is a great challenge to economic development. For this reason the lack of FDI ("Foreign direct investment") in a country. Because, no country will participate in religious extremist country, because they afraid of the socio-economic security and investment return. Confidence also affect on this investors. As can be seen, In 2022 one billion USD of FDI comes to Pakistan. In contrast, 74 billion USD has been invested in India for the purpose of



FDI. Even though, Apple invested 40 billion USD in India for economic cooperation and development. Because of the India has the world growing economy and world second largest democratic state intensively. Furthermore, the economic friendly environment attract foreign direct investment into the country. Additionally, Afghanistan government before the Taliban government, and pre US withdrawal in astrafy Ghani government (Foreign direct investment) FDI was 39 million USD. But, in view of Taliban religious extremist government the foreign direct investment fallen to 13 million USD according to the report of UN (United nation development program). It is extremely necessary for the attraction of foreign direct investment program "FDI" there should be no religious

extremism. Frequently, the role of religious extremism in countries where socio-economic activities disturb very brutally. It is important to realize that country socio-economic affairs should be kept aside from such activities which can significantly fragile the economic development. In other words the case study of "Priyamtha Kumara" Diyawadana a 49 year old Sri Lankan man who worked as a general manager of a factory in Sialkot, Punjab Pakistan was lynched by a mob over allegations of blasphemy. The mob tortured, killed and burned his body which was captured in horrific videos shared on social media. The lynching was characterized by a religious extremism, and it was linked with Pakistan blasphemy laws, which have been used to justify violence against religious extremism on minorities.

It is most compelling evidence that the killing of the minorities impact on the international arena and also impact on the (foreign direct investment) in Pakistan.

Religious extremism threat to economic development. Disruption in economic activities due to extremist violence by extremist groups used violent action to achieve their greivous. As can be seen the TTP (Tehreek-e-Taliban-Pakistan) extremist actions disrupt the economic situation of Pakistan. The role of extremist groups in Pakistan slow down the economy, effect the foreign direct investment and people migrated from the local markets, for the fear that the local market has been disturbed. The Extremist groups violent action to sabotage the state socio-economic situation. TTP (Tehreek-e-Taliban-Pakistan)

Protest in favour of Plassey case and protest in the mid of twin cities Islamabad and Rawalpindi and stop the main expressway, by which the thousands of the people were disturbed due to the mob and protest, which causes that the school colleges were closed, trade activities halted.

According to the "Special Assistant to Chief Minister of Punjab" "Hassan Khawar" says "Pakistan losted 35 billions ruppees due to religious extremism. They demanded to exile the France Embasada from country. Their action in reality halted the international image in the international arena and blamed by the international actor that Pakistan supporting the Extremist groups in Pakistan. As a result Pakistan had remain in grey list of FATF (Financial action task force).

There are two books references which support the argument related to use a "blasphemy" as a tool by Extremist groups to mobilized the innocent groups to fulfilled their grivences.

Security concern springing from religious extremism undermine by economic development. Extremism create terrorist groups and make security concern. Because the hate speech used by extremist groups against other religion and sect to mobilize the innocent people brain washing let people and young generation into suicide attack and create security concern to the state and disrupt the socio-economic situation of the state.

Wasting human resource due to gender discrimination due to

religious extremism discourages the working of women. For this reason most of women living dependent life in society. In other words women has the main workforce which has be marginalized by the extremist groups to ban of women in workplace. Notably, Taliban ban women in working with NGO's and workplace in Jan 2023. It is the most compelling evidence to highlighting the role of religious extremist to undermine the economic development in the state and also take ban on the school and college for women. As a result the economic disparities arises. NGO's activities ban during the Taliban government which discourage the billion dollar in favour of the providing skill and vocational training and support program. According to the WEF (World Economic Forum) and (Global Gender development

Gap index the IRAN (150/156) Participation of women. According to World bank 20% women and 80% men working full contributing in economic activities.

Effect on tourism due to religious extremism, the economic development has disturbed. According to the Economic Review of Pakistan,

In 2013 - 380 billion loss due to the role of religious extremism in the country. Because the tourism only attract when the state has free from any type of terrorist attacks and free from religious extremism. That is only possible that everyone all over the world to insure the safety and peace. People avoid such places to visit when the religious extremism on peak. Pakistan loss in tourism industry Pre 9/11 there was a one million per year but after ~~at~~ 9/11 there was only 10,000 people visited Pakistan. But in other fact

that Turkey earned from tourism industries about 56 billion USD.

Keeping in view above facts and figure it shows that the internal peace and stability was very important to attract tourist and investment to ensure socio-economic development in the state.

Syrian ISIS conflict drastically destroyed the internal peace and stability of the state by which most of the Engineer and doctor and other professional leave the country. 15000 doctor due to ISIS leave country. Because the engineers and doctor are the main workforce of any state, if they leave then the socio-economic situation would be beyond. According to the report by "State Bank of Pakistan" 885000 migrated from the Pakistan.
