## Introduction

Aristotal classification of state and government is the first systematic but not scientific classification. It is different from J.A.R Marriott and Dr. Leacock classification because their classification are more comprehensive in nature.

Aristotle classify state and government on the basis of number of people and how they exercise the supreme power of the state. It was criticize by many philosopher such as Dr. Leacock, Seely and Garner. Aristotle didnot give a comprehensive overview on state, such as to explain difference between Despotism and monarchy, democracy and Constitutional democracy, presidential and parliamentary, and federal and unitary form of government.

Moreover, Aristotle's Classification is suitable for Greek City-states not for modern States.

## (2) Explanation:

The Aristotelian Classification is based on two principles. The one form change into another when king use/exercised for self interest. So, people starts uprising and topple the government and then establish new form of government which are given in detail.

### (a) Principles of Classification

⇒ The Supreme leaders or king exercise power for the welfare of state or for self interest.

### (E) Dr Leacock and Seely opinions on Aristotle classification.

Dr. Leacock and Seely criticize Aristotelian classification in terms of modern forms of government such as, monarchy, constitutional monarchy, democracy and unitary and federal form of government.

(a) fails in differentiating between monarchy and constitutional monarchy. Aristotelian classification of state

and government fails to explain constitutional monarchy and monarchy.

(b) fails to explain constitutional monarchy and democracy.

Aristotelian classification cannot explain constitution and democracy difference.

E.g. UK has constitutional monarchy but called a democracy.

The classification cannot give idea or explain the concept of parliamentary and presidential form of government.
