(Research from strategic communication firm Roedel Partners in 2018 revealed that: Nearly half of Gen-Z ranked Youtube as their first or second most important source of News)

III. How Scarcity of Truth is prevalent in Contemporary Print and Electronic Media:

3a) Governments, Big Institutions, and Corporations know how to play the Media Game.

(Noam Chomsky's "Manufacturing Consent: The Five Pillars of Mass Media")

3b) Role of Influencers in Overtaking Journalism and Spreading misleading content among the public masses.

(The Reuters Institute for the Study of Journalism found that "influencers"

are overtaking credible journalists as news sources, and fewer people trust traditional media, whereas more people turning to TikTok for news.)

3c) Commercial use of promoting sensationalism and clickbait, shaping public perception and creating distrust.

(A 2020 Gallup Poll revealed that only 40% of Americans trust the mass media to report the news "fully, accurately, and fairly")

3d) Manipulation of democratic Elections by misinformation and disinformation on media platforms.

(Example: Political disinformation spread by Robocalls to approximately 5000 to 25000 calls that disrupted the New Hampshire presidential elections. Also, suppressing voters).

3e) Potential of AI-Generative Content ~~exacerbating~~ massive disinformation

campaigns and feeding radicalising process of Propaganda.

(According to the News report of The World; AI-Generative Images in Europe has been generated promoting hate speech and Islamophobic content against Muslim Immigrants).

3f) Justification of Genocidal War by Israel against Innocent Palestinians, using AI-deceptive content.

(Digital Dilemma, A report by Al-Jazeera, revealed that Tel-Aviv Stoic Company spend \$2 million, generating Pro-Israeli content)

3g) The Idea of Circular Reporting.

3h) The Misinformation is flying and the truth is lagging behind.

(In 2021, research from UK Safer Internet Center explored how half of ^{48%} young people encounter misleading content on daily basis, with more than one in 10 seeing it more than 6 times a day).
