(i) - Ijtihad:

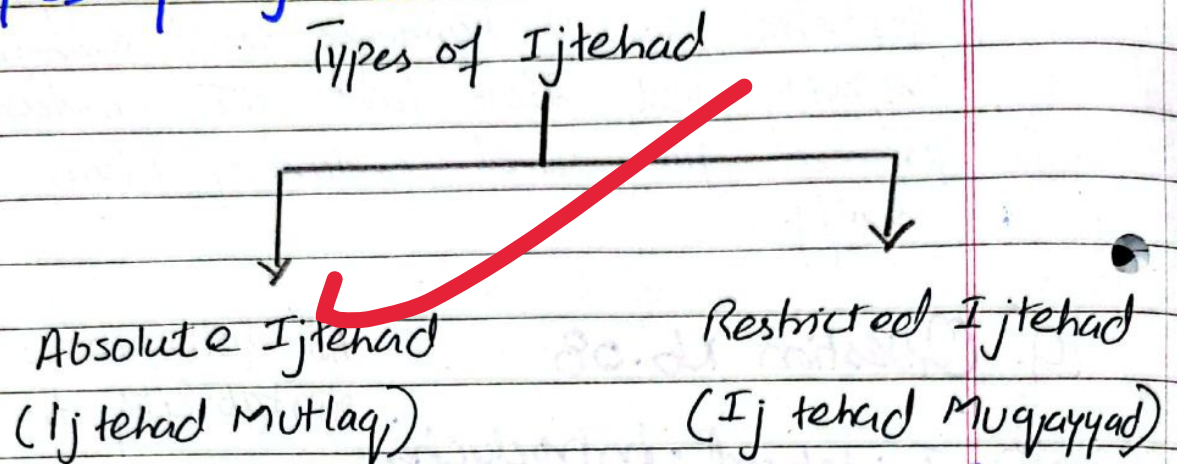
Ijtihad is a Islamic legal term referring to independent reasoning to deduce legal rulings from the fundamental texts of Islam, the Quran, and the Sunnah. It derived from the Arabic word 'jihad' which means effort or endeavor, ijtihad plays a crucial role in adapting Islamic law to changing circumstances and new issues that arise over time.

- Principles and conditions:

For ijtihad to be valid, several conditions must be met. The mujtahid (one who performs ijtihad) must possess a deep understanding of the Quran, the Sunnah, consensus (ijma) and analogy (qiyas). They must be well-versed in Arabic language, Islamic theology, and jurisprudence principles. Ijtihad is typically applied in situations where explicit texts (man) do not provide

clear guidance, necessitating a reasoned interpretation.

- Types of Ijtihad.



i) Absolute Ijtihad (Ijtihad Mutlaq):

This refers to a independent reasoning by a scholar who meets the highest qualifications of mujtahid, capable of deriving legal rulings without relying on any particular school of thought.

ii) Restricted Ijtihad (Ijtihad Muqayyad):

This involves reasoning within the framework of a established legal school (madhhab), adhering to its fundamental principles while deriving new rulings.

Islam establishes several mechanisms to ensure accountability:

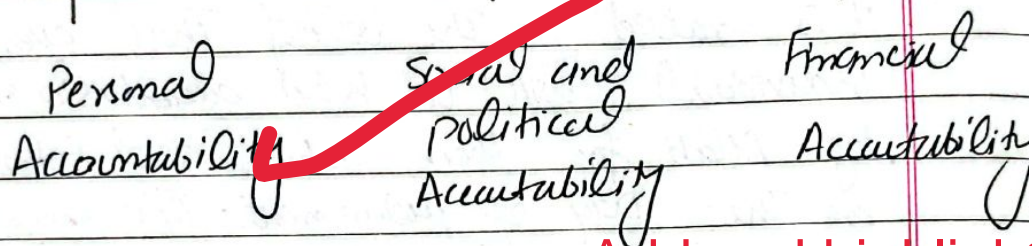
