Political instability and inequality further leads to insecurity for the state which results in surveillance and control of its own citizen. To avoid any type of uprising or protest, state ensures that it balances by controlling its people's behaviour. For this purpose, different types of tools are used and methods are implemented. These methods and tools help government and security agencies to hack data results in targeting of human rights. Pegasus is a software that is especially used for such purposes in which human rights defenders and civilian society is targeted unlawfully by hacking their data. how surveillance and control affects human rights.

In accordance with surveillance and control, there is another factor that is detrimental to human rights is ~~lack of justice~~. A state where autocracy becomes a norm and there is no respect for the mandate of people, injustice emerges. When ~~justice is not served~~, arbitrary deprivation of life and other unlawful activities become a norm in that society. According to the 2022 country reports by Human Rights Practices by US department of state in 2022, significant human rights violation took place in Pakistan including ~~unlawful~~ killings, forced disappearance, torture and cases of cruel, degrading treatment by government agents, arbitrary detention, and political prisoners etc. All these unlawful crimes ~~lead to have a negative~~ affect on the lives of citizens.

 of activists exists due to the  
 fear of state that the people



might demand their rights with the help of activists. Often times the government with weak mandate and having extractive institutions start repression against the activists of that country. Repression occurs due to the demand from the government which the government is unable to fulfill. When Felix Tshisekedi became a president for the second time of Democratic Republic of Congo, country witnessed a surge in activities that were unlawful against activists. (Sarah Jackson, DR Congo's arrest of activists, February 2024). Thus it shows how one of the major violations of human rights is repression against activists.

Misuse of technology to suppress activists and citizens to violate their human rights is becoming a common practice. The technology with the passage of time is becoming more and more dangerous because of its negative use by the people, state

media, government or non-state actors. During the time of conflict, media is used to spread negative propaganda which tend to create bundle of lies and impede the truth.

In particular, deepfake technology is used by people to target other people by making their fake voices and images generated through Artificial intelligence. Hence, this misuse of technology shows us how technology is used to violate rights of people.

Besides these causes of human right violations, these violations have also negative impact on humans. There are several impacts on lives of people, chief among which stands is rise in extremism.

Individuals with mental health issues are often facing or have faced human rights violations once in their life time at family, society, employment or community level.

(Rabab Ahmed, Mental distress and HR violations, Jan 2021). It shows how one of the impact of human right violation can be mental health.

Mental illness due to such violations can also result in loss of community and culture for individual. Long-term consequences due to these violations result in loss of societies and their culture

which is also a most adverse impact one can face. People are often denied their rights because of the ethnicity, religion or culture they belong to and specially during the period of conflict communities and cultures specifically of minorities are attacked. "To deny people their human rights is to challenge their very humanity" (Nelson Mandela, Long Walk

to Freedom, 1994). Therefore, loss of community and culture is one of the severe impact of rights violation.

Other than the impacts discussed above, one impact and implication of human rights is illegal detention of people. When the justice system is weak, such factors become norms and state structure become autocratic. In a conflict, one side which is winning starts illegal detentions of the people of losing side. These illegal detentions are clear violations of basic rights of people and also international law. After the start of Israel-Gaza war, about 270 Palestinian are detained without any charge shows that how Israel is clearly violating human right violations against Palestinian people (Maziar Motamendi, Tailed without charge, November 2023). All this shows that how illegal detentions are a negative impact of violations against citizens rights.

To maintain its strong hold, state uses other methods that impacts human rights along with illegal detention of people, one of which is ~~breach in privacy~~. ~~Privacy of a person is~~ undermined by the government to protect its interest and avoid any uprising. In this modern ~~era~~, many tools and methods ~~are~~ used. During cold-war era, the ~~Soviet~~ in East Germany used wiretapping, intercepting mail and even planting bugs in people's homes. This invasion of privacy instilled sense of fear and mistrust in society.

These <sup>Human's</sup> implications of human right violation on human life can be protected during a conflict by implementing several factors. The most important measure that can be taken against these violations is implementation of Human rights rules and regulations.



International and local bodies have come up with different policies and law that should be implemented to protect human lives during conflict at any cost. These policies are usually regulated by the governments of that country so it can secure lives of its people. In his letter in 1809 to Republicans of Washington County Thomas Jefferson stated that "The care of human life and happiness, and not their destruction is the first and only object of good government." It shows that how implementation of rules and regulation by good governance can protect human lives.

By not only implementing these rules and regulations but also other policies such as non-proliferation of weapons can protect people lives. During war time, weapons are the most destructive for any society or

country. Non-proliferation of weapons is a measure to control arms race in the world so that the world can remain safe from the vast destruction. The Nuclear Non-Proliferation Treaty signed in 1968 was an agreement in which major nuclear and non-nuclear powers pledged their contribution in stemming the spread of nuclear technology. Hence, non-proliferation of weapons can protect human lives.

In a conflict, human rights activists are on the frontline to help the victims of that conflict so protecting them will automatically protect human rights. Human rights defenders collect data and support victims to access justice, and foster dialogue and mediate between state and communities. The UN General Assembly adopted the Declaration of Human Rights Defenders in 1998 to protect rights of people

who are involved in protecting human rights. Through these steps, the state can protect its citizens.
