2 The Creation of new Provinces:


Negative Implications

i) Floodgate of creation of new provinces

The first and foremost

argument against the demand of the creation of new provinces is that it will open a floodgate of new provinces.

In Pakistan, various demands from different section are raised for separate provinces.

ii) Issue of new agreements between Center and new provinces

The second issue is that

the existing agreements that are solely responsible for maintaining the

administrative and political and financial relations between center and provinces would be revised. For instance, NFC Award, Council of common interest, and division of administrative duties would be revised in the case of the creation of new provinces. It seems very difficult at the present situation because of existing difference among political elite of the country.

(iii) Absence of required finance

The creation of new provinces also demands finance for infrastructure development and other provincial departments. Currently, Pakistan is facing economic crisis and it is relying on IMF. Therefore, it is not a viable option to create new provinces.

As the name changing of KPK costed 8 billion to the country. In these circumstances, it seems unfair to demand for new provinces when the country is facing severe economic crisis.


