In addition, According to Rule of Law Index Pakistan ranks 130th out of 142 in world wide.

As the 3rd world countries are mostly corrupt countries and Pakistan ranks 133/180 in corruption in 2023 according to Transparency Index.

It is a clear stance that neither muslim countries nor ^{most} south Asian most of the countries prevail democracy.
