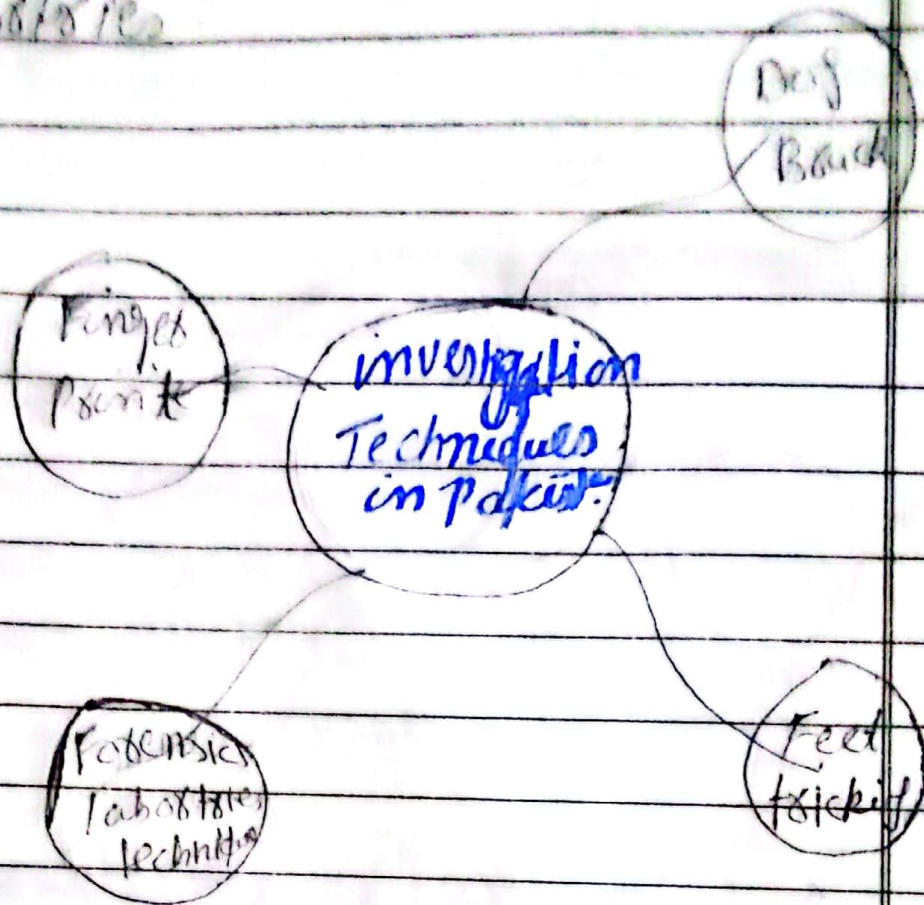
Write a comprehensive note on the principles of criminal investigation illustrate example from Pakistan.

Preserve relevant evidence to established it value in court to prove crime.

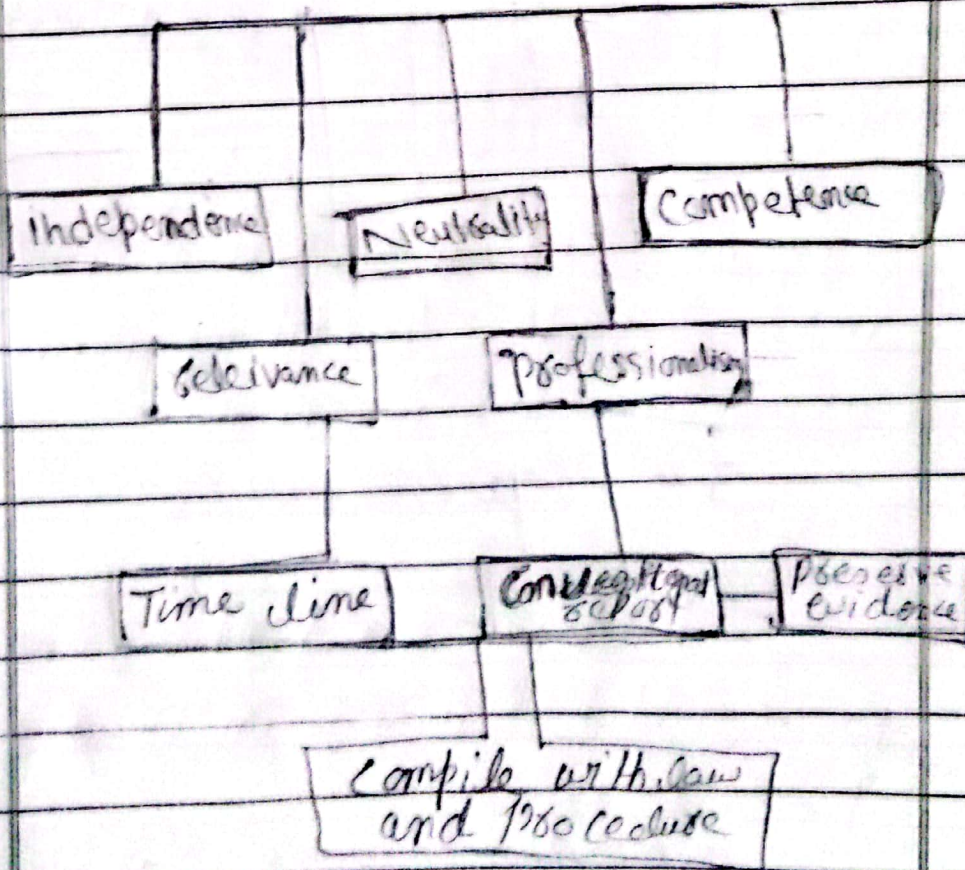
3.5. Conclusion Report.

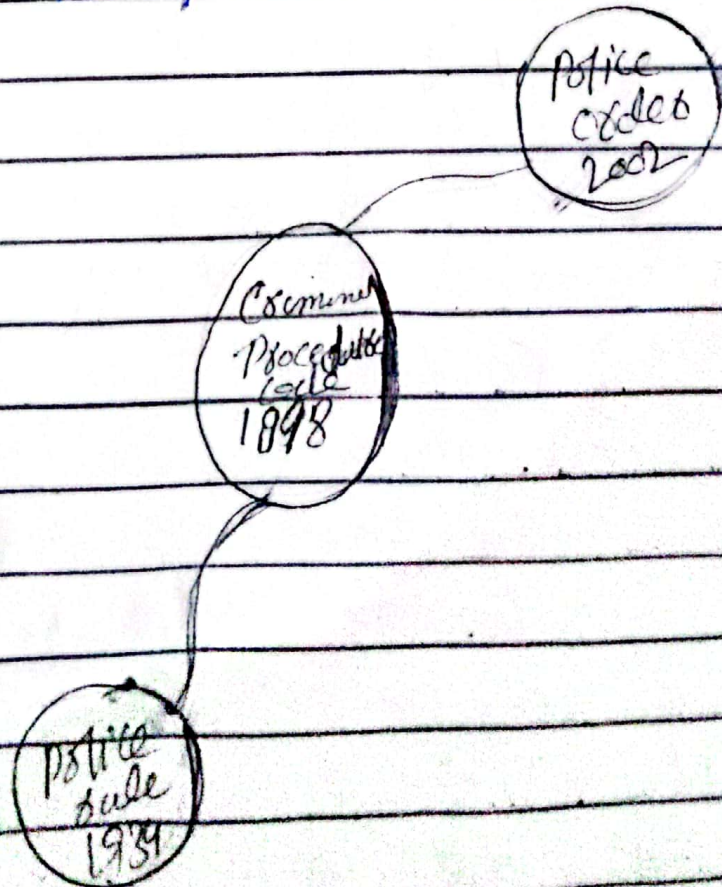
