modern women faces many problems to get higher education. Patriarchal society where man considers primary authority and women are subordinate. This has serious implications on female life prospects. Because families prefer boys to educate whereas the primary responsibility of a girl is considered to be at home chores. Simultaneously poverty is another hindrance to women education. According to the ministry of Planning and reforms, half of the population in Pakistan are unable to afford basic necessities of life. Even middle class families

hardly bears the high costs of private institutes. Therefore the prefer boys to send boys to school because they are considered breadwinners of families and girls are kept in home to train them in household in addition to. Early marriages also presents an obstacle for women in getting proper education. The conceptualization of girl child as 'other's property' who has to eventually move to her husband's home prevents parents from investing in their daughters' education. Next come, lack of transport facilities also affect women to getting education. Women do not have proper transport facilities use of family owned vehicles is subject to the availability of the males of the family woman alone cannot drive because of prevalent social taboos like women should not travel alone. an should not drive alone.

the other hand, public transport has its own issues. The women sections of public transport is mostly filled with men leaving only one or two vacant seats for women. There are significant safety concerns at bus stops about eighty percent of women commuters report harassment at bus stops according to a recent Foundation. These hardships affect the social status of women.
