Origin and History

Pakistan Special Police Establishment (PSPE) used to operate to investigate and prosecute the officials of federal government against bribery and corruption. Later on, it was realized that a special investigation organ is need of the hour with specific expertise to carry on technical assignments. However, FIA established under FIA Act of 1974.

Organizational structure

FIA is headed by Director General of police, grade 20. The DG is assisted by Additional DGs. They have their staff in hierarchical structure.

Different wings of FIA deals with the controlling of Organized Crime.

① Counter Terrorism Wing

This wing has been established to strengthen the national security, internal and external, of the country. This wing struggles against terror financing, cyber-terrorism, and terrorism. It act upon the activities and assignments which government of Pakistan entrust.

② Immigration Wing

It was established in the year 1975. This wing acts upon the Prevention of In person Trafficking Act 2018 and Prevention of Smuggling of Migrant Act of 2018. This wing holds power to arrest and detain a person accused of any inconvenience.

It can also arrest a person on the direction of police and other Law Enforcement Agency. It's the duty of the organization to look upon the visas of tourist and business person on arrival. It arrest the individual or a group of travelling with fake documents or identity. Immigration wing keeps an eye on arriving and departing passengers at airport. Besides that, there are 27 checkpoints or international airports and FIA's wing is bound to make its presence at all of them.

3) Technical Wing

The technical wing of FIA provides technical, forensic and scientific assistance in various cases of FIA.

4) Anti-Human Trafficking and Smuggling Wing

This wing of FIA marches against wide range of human trafficking and migrant smuggling. It publishes a Red Book annually to make a shoutout against renowned smugglers and to create awareness.

It provides guidance to the Government to craft policies and rules to prevent Human trafficking. Further-more, it works on the capacity building of PIA works on Human Trafficking and migrant smuggling. Besides it, it also coordinates with UNODC, IOM (International Organization for Migration) and IOM (International Centre for Migrant Policy Development).

5) Cyber Crime Wing.

- It is the only wing of PIA that directly receives the complaints of people and act upon it to settle it.
- The mandate of Cyber Crime Wing includes: Cyber-bullying, Cyber-Harassment, Cyber-Terrorism, and Cyber-Threatening etc.
- This wing of PIA has technical expertise in technical investigation, Digital Forensics, Information System, security audits etc.
- The specialized wing acts upon the laws of "Prevention of Electronic Crime Act (PECA) 2016, which deals with the rapid growing threat of Cyber crime

(6) Intellectual Property Rights (IPR)

- Established in 2007.
- The Intellectual Property Right wing of FIA is bound to protect the Patents of company, Logos, Copyright, Trade Mark, trade secret, trade name etc.
- This wing also advises the government of crafting the policies regarding I.P.R.
- Moreover, it enforces the laws with the help of Law Enforcement Agencies such as Police, Customs Police.

(7) Economic Crimes Wing

Economic Crime wing deals with the financial crimes, such as, Money Laundering, Alternate Remittances (Hawala, Hundi) illegal Money occupying and etc.

- This wing analyse the laws related to economic crimes and suggests amendments to the government.

(d) Anti-Corruption Wing.

- > The wing of FIA deals with corruption, Terrorism and Human Trafficking.
- > It monitors the working of FIA zonal Directorates related to anti-corruption laws, fake drugs, Theft of Electricity and Gas and oil (EGOA), violation of Human Organ Transplant Act (HOTA) Intellectual Property Rights etc.
- > It also oversees the receipts and disposal of complaints received from Ministries, National Assembly, Senate, Presidential Secretariat, Prime Minister, Wajeez Mohtasib etc.

Classical School of Thought
