The next seven paragraphs will describe why being a minority is a fate no one wants, in . The first factor is historical warfare and enmity. Historically, minorities are faced with discrimination and oppression. The reason behind this can be many, such as ideological, political, economic, and social aspects. For instance, in context of religious holy wars, minority suffers the most. They were <sup>either</sup> persecuted or imprisoned. They faced the brunt of Holy wars back in medieval period. The fifth challenge in this sequence is social marginalization and intolerance.

They have their own isolated communities. Likewise, the intolerant society is also a challenge for their peaceful survival. The Hindutva politics in India is its prime example. Through these policies, muslims in Kashmir have marginalized from majority to minority. The extremist Hindus are illegally occupying muslims properties in Indian held Kashmir. Therefore, social marginalization and intolerance is a bigger challenge to minority to live a peaceful life.

The sixth challenge that exists in the mind of minority is psychological inferiority complex. Due to their lesser numbers
