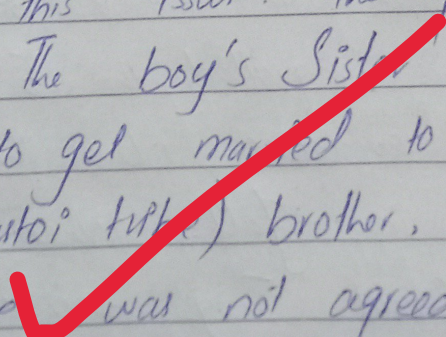


Explain the structural and direct form of violence against women in Pakistani Society by highlighting Case of Mukhtaran Mai

INCIDENT OF SEXUAL VIOLENCE

Start with the summary of the answer as introduction

On June 22, 2002 a boy was accused of having sexual relation with 20-year-old girl of Mastoi tribe. The boy was 12 year old. A panchayat was held on this issue. The panchayat decided that the boy's sister "Mukhtaran Mai" have to get married to the Salm's (women of Mastoi tribe) brother, Abdul Khaliq Mastoi.  was not agreed on it. Later it was decided that the boy's sister (Mukhtaran Mai) will apologise for her brother's crime. Mukhtaran Mai

was agreed to do that. when she came to appolised, she was dragged into a hut and rapped by four men, upon the Order panchayat (Jirga).

## FAILURE OF PAKISTANI JUDICIARY TO PROVIDE JUSTICE

After Eight days of incident The case was filled in the police station against mastoi's tribe. After first trial, 14 men were arrested, out of them 6 men were sentenced to death. in these 6 men, 4 were involved in Rape and remaining two were involved panchayat of making decision. The 8 men were Released. When Mukhtar Mai filled case in Lahore high Court. They acquitted the 5 men due to lack of evidence now there was just one person in jail. When she appeal in Supreme Court. They decide that they upheld the Lahore's High Court decision. it take alot of time even the year to seek Justice but she failed to get Justice.

### Direct Violence.

Like sexual violence, physical violence, torturing,  
killing etc.

### Direct violence in Mukhtaran Mai Case.

in Mukhtaran  
Mai's case direct (sexual violence) take place.  
it shows in Pakistan how women face direct  
violence.

### Sexual Violence:-

The people of Mastoi tribe raped  
the Mukhtaran Mai. it is sexual violence  
Another thing that it shows is  
How women's in Pakistan have to live

of their family.

## Structural violence :-

it is a form of indirect violence. that show how people with wealth and authority deprived the other from their Basic Human Right.

## Structural violence in Mukhtaran Mai's Case

There are a number of factor in the Mukhtaran Mai's Case that show how structural and indirect violence exist in Our Society.

## Class factor

Mai was belonged to a poor family. she was unable to Read and write. in her Statement she Said to police that she did not know how to fill a case. what should I tell. you just Record it by asking Question from me. she belonged to lower class family so she feel may delayed in her case. if she belonged to

Rich and educated family she could  
pressurized the ~~case~~ police for proper investigation.  
it shows that in Pakistan lower and  
middle class people are deprived from  
the Justice even they do not know  
about their Rights.

In another statement Mai Revealed that  
the federal Minister for defence, Sardar  
Abdul Qayyum Jatoi pressurized her not  
to file a case against accused  
persons of Mastoi tribe. That show  
how the person with authority misused  
their status to silence the Justice or  
to silence the victim.
