and ill-mannerism.

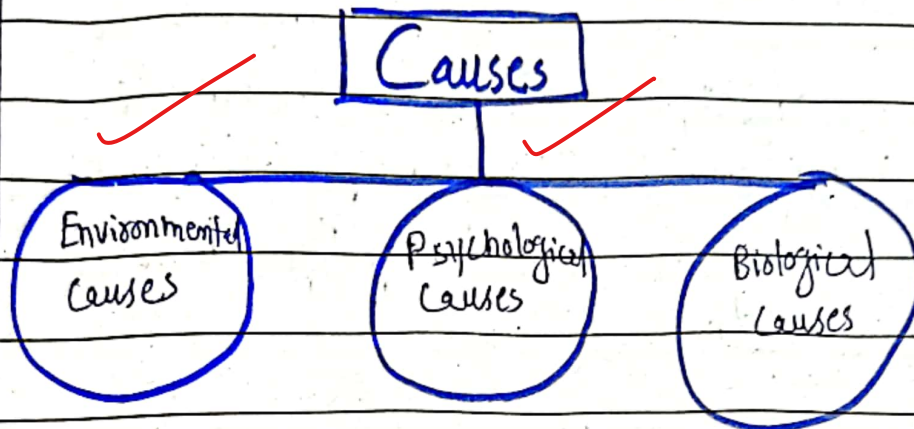
### (iii) Legal Definition:

### 3. Causes of Juvenile Delinquency in Pakistan.

There are various causes of juvenile delinquency in Pakistan.



#### (i) Environmental Causes:

There are various environmental causes that are affecting a juvenile to commit a crime, especially in Pakistan.

##### • Lack of education:

It is one of the important issues in Pakistan because children are often kept away from education. According to

UN Report "2.5m students are out of school". Due to lack of education, they commit crimes.

### • Fostering Poverty:

There is

abject poverty in Pakistan which forces juvenile to opt a wrong way in order to fulfill their desires.

### • Family Problems:

Family issues

are core reason for child to act which is morally and legally wrong. According to Seigel, due to lack of bonding in family, children often opt wrong way.

### • Community Pressure

Community

also plays an important role because they force a kid to realize his failure. As a result, he commits crime to escape from

societal pressure.

## (ii) Psychological Cause:

There are several psychological causes which force a juvenile to go for crime.

### • Concept of superego: An analysis by Sigmund Freud.

There are various children who become the victim of superego or superego. In this, juvenile takes it serious and thoroughly. This factor is also prevalent in Pakistan because the concept of superego is found in many juvenile that force them to commit crime.

### • Behavioral Theory:

Many juvenile in Pakistan often learn from their ambience which is morally and legally wrong. Due to their surrounding,

they commit crime in Pakistan.

### • Cognitive Theory:

Many children

start considering themselves as divergent and resilient. As a result, they indulge in the practice of crime. It is often seen in Pakistani juveniles.

### (iii) Biological Causes

Several crimes and acts conducted by juvenile due to biological factors.

### • Shelton's Model:

Shelton is a scientist who represents a model which consists three bodies i.e fat, average, and thin. He depicted that juvenile commits crime due to their body structure. In Pakistan, it is often observed.

## • Genetical Problem

These are various problems in Pakistan which are related to genetics, such as inherently qualities of parents. This force a kid to do the wrong. For example, xxy, xyy.

## • Hormone levels

Many juveniles are committing crimes in Pakistan due to hormone levels. They are not given reverence and respect which force them to commit crimes.

## • Malnutrition issue:

Many Pakistani juveniles are facing nutrition issues due to lack of food and poverty, thus force them to opt wrong dissection in order to fulfil their stomach.

### 1. Introduction:

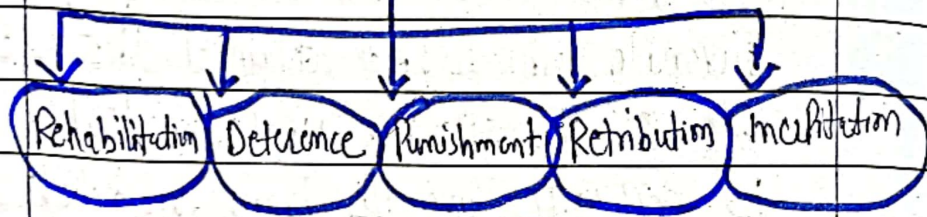

## 2. Cursory look on Criminal Justice System.

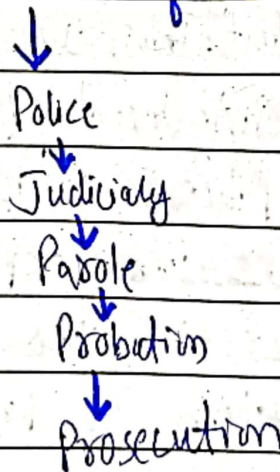
Criminal Justice

### 3. In the Presence of the Criminal Justice system, why the Juvenile Justice system was introduced:

Although there was a criminal justice system, juvenile were treated same as other ordinary criminal which forces to create another system which is based on juvenile justice system only.

Following are the points which highlights the need of why the juvenile justice system was introduced:

- In ancient times, children were treated same as adult criminal.
- If a child is committing any crime, it will lead to death penalty.
- Massachusetts colony passed a bill in 1646 which explains  
"If any child commits a crime, these parents will be responsible for it and their parents will be put into death penalty."
- Hardships of juveniles were

high because they were compared as adult criminals.

- In 19th C, people started realizing due to socio-economic changes.

- 1899, the US passed a bill that mentioned the separation of juvenile justice system from criminal justice system.

Following are the developments due to a bill passed by the US:

(i) Separation of Joint family from Joint to Nucleated:

The development emphasized the separation of nucleated family from joint family because children cannot get desired love in joint family. Thus, they commit crime. Therefore, it is necessary to separate the family so that ~~the~~ child can get proper love.

and affection from his parents.

According to Seigel:

"Children should be given love and affection. Thus, it is necessary that they live separately from joint family. And parents should not force their children to marry according to their choice."

(ii) Laws for Juvenile:

If there is a child who belongs from poor family, he will be put in the wealthier family where he can learn skills and art until the age of 18. In this, state can play positive role to ensure the safety of a child.

(iii) State as a parent:

State should serve as a parent for those who are disable, fragil, and suffering from any disease.

#### (iv) Child saving Movement:

After the revolution, there was a child saving movement which focused on the separation of juvenile justice system from criminal and ensured the rights of a juvenile.

#### 4. Role of a Police in the Juvenile Justice system of Pakistan (JJS)

Juvenile justice system of Pakistan is one of the important factors which is protected by police. Police plays an important role in ensuring JJS of Pakistan because it is considered as first step of defense. Thus, it helps juvenile to protect their identity, ban of handcuffs and to inform their parents if any juvenile commits crime.

### (i) Identify the Juvenile:

According to Juvenile Justice system of Police act 2018, section 8, it depicts that police should identify the juvenile if he is under age or not on the basis of his other documents.

### (ii) Ban on chains to juvenile

It is clearly indicated in the Police order that there should be no chains to juvenile if he is committing crime because chains cannot affect his cognitive approach.

### (iii) Inform the Parents of Juvenile

Police can inform the parents of juvenile if he or she is committing crime. Because, it will be helpful for juvenile if his parents are aware of it and can arrange primitive measures.

(iv) Proceeding of courts should not revealed:

It is one of the important factors that police should not reveal the proceeding of courts because it might affect the mentality of a juvenile.

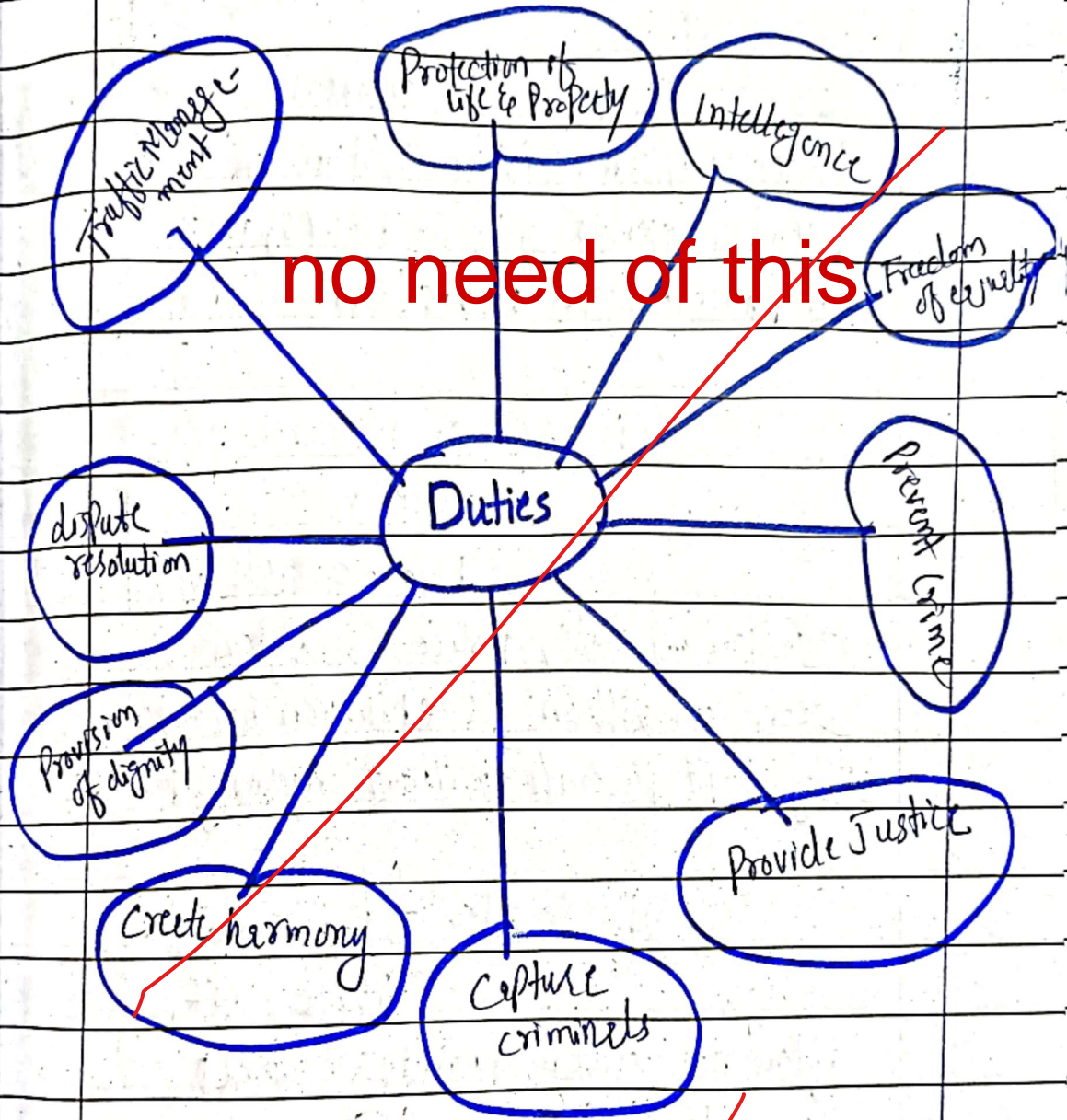
(v) Keeping juvenile under home observation:
