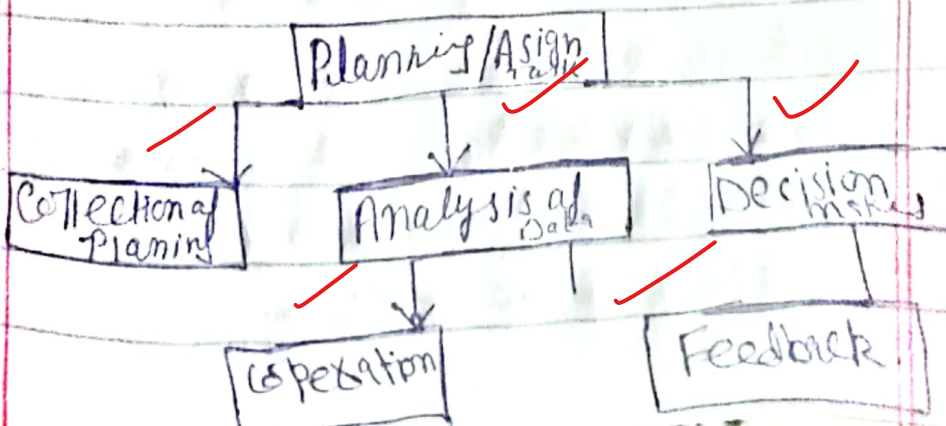

- (2) involvement of local helpful to tackle the crimes in area.

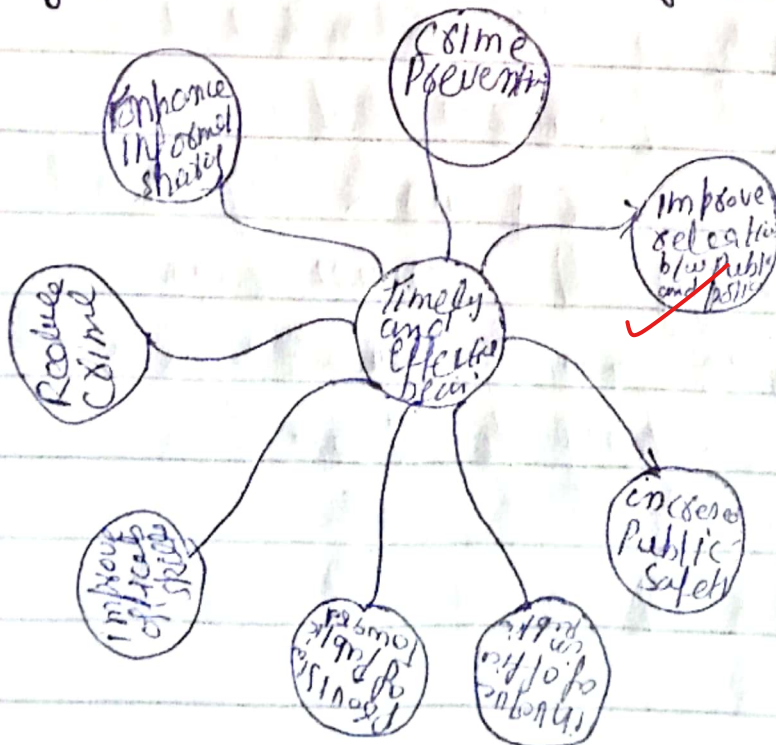
