(4) Definition of Radicalism

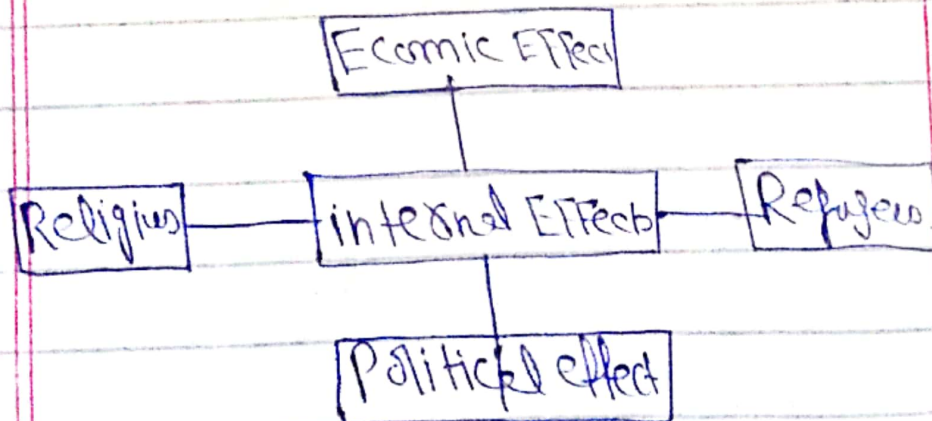
The use of any idea or view which promote extremism is called Radicalism. It promotes the terrorism activities and leads by extremism force.
