The role of citizens within democracy is not restricted to the right of voting. Within democracies, citizens are expected to play an active role in governance and policy-making. not politically aware. Similar examples exist in the case of Mexico during 1980s till early 2000s. The Mexican population, lacked political awareness due to low literacy rate and state-controlled media.

The Institutional Revolutionary Party (PRI) dominated Mexican politics for about 71 years despite being highly corrupt and serving the interests of prominent drug cartels. However, the absence of political awareness among the Mexican populace made Mexico a one-party state with a corrupt leadership.

Absence of effective citizen participation reduces the principles of transparency and accountability of the political class. Resultantly, an elite-capture emerges and policy-making becomes dominated by individuals who design policies to serve their self-interest. The essence of democracy, which promotes participatory policy-making and condemns elite-capture, fades away. Political awareness is the

regulator which keeps citizens aware so that they ensure accountability within a democracy takes place.

The absence of such regulations leads to elite-capture which undermines the principles of democracy.

As the process of policy-making is captured by the elites and decisions are formed against popular interest, social fragmentation emerges.

The lack of mutual understanding and agreement within the society has a detrimental impact on social unity.

For example, within Pakistan there is serious criticism over Punjab-centric policymaking. As political

Provided the absence of effective citizen contribution due to lack of political awareness, unpopular decision-making takes place. Democracies serve the majority and unpopular decision-making is not democratic. Such undemocratic actions erode public trust within state institutions. The disconnect between citizens and state institutions compromises the social contract upon which the entire concept of democracy is upheld. As a result, the state of democracy in such countries becomes more prone to failure and collapse.

Weakened public trust and declining social contract, breeds divisions among the society. Such situations create a highly unstable political climate, making the country highly susceptible to autocracy. The resurgence of trust and social cohesion cannot take place unless political

awareness is focused upon. However, in situations where political awareness is absent, such divisions keep on destabilising the political environment within the country, eventually leading to the rise of an autocratic leader.

Political awareness is controlled by the creation of barriers by powers whose interests are served within a weakened democracy. The control over narrative by subjugating media is a popularly employed tactic to restrict political awareness. Media play a key role in a dysfunctional democratic environment and ensures political awareness. Controlling the media restricts political awareness as limited information reaches the citizens which itself is tweaked and biased.

Education and political awareness are positively correlated. Lack of education or civic awareness

programs, limits political awareness within a society. UNESCO's Global Education Monitoring Report (GEMR) discusses that people with only primary education are much more likely to be politically aware and thus fail to contribute within the political sphere of a country. Moreover, OECD's Programme for International Student Assessment (PISA) conducted a study on Global Competence among youth. The study concluded that students with low educational attainment score significantly lower on two indicators: civic literacy and political awareness. Thus, countries with low education rates create barriers towards their citizens attaining political awareness.

The Democracy Index by The Economist Intelligence Unit ranks countries based on five key democratic principles. Among the five democratic principles are civic liberties, political participation, and political culture.

Countries which restrict participation such as ~~advocacy~~, debates, and protests, create a barrier towards higher political awareness within the society. Resultantly, democracy is compromised and such nations fail to be classified as full democracies by the index.

Political awareness is further suppressed by within countries where one state organ out of the three branches of government plays an overarching role, establishing autocratic domination. In most cases this state organ is the armed forces. To ensure the interests of the deep state are served, political awareness among the citizens is highly restricted. Such democracies are essentially hybrid or autocratic regimes under the pretense of democracies.
