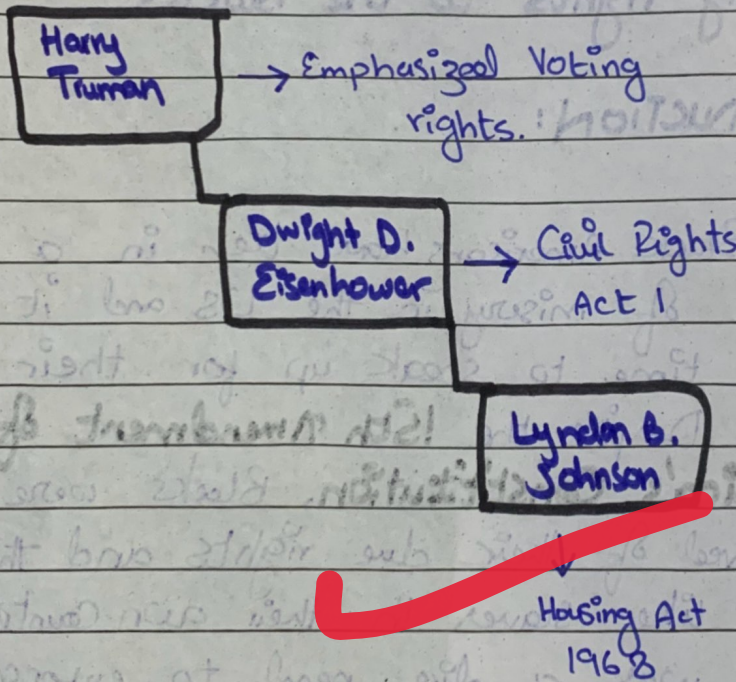

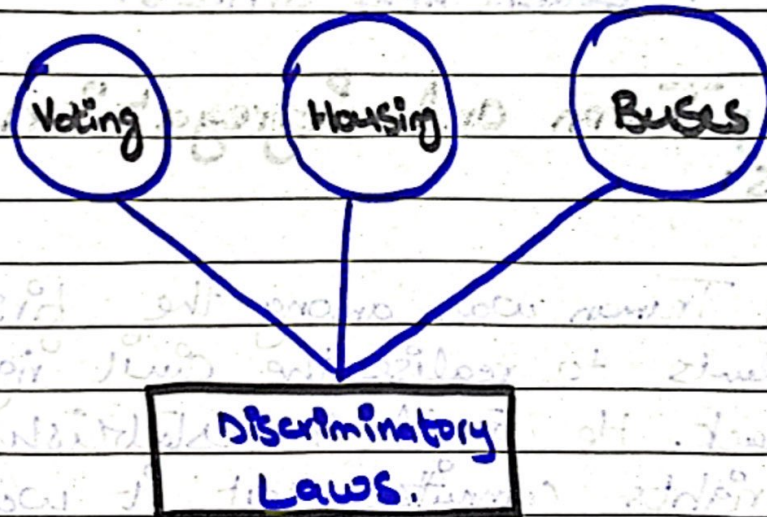
Rosa Parks and the beginning of Civil Rights Movement:

Civil Rights Movement begin in 1950s

when Rosa Park, a black lady refused to give her seat to a white man. According to different scholars she got arrested. From this time onward, leaders like Martin Luther King emerged as a black leader and vowed to take steps to give Black people their rights.

• Laws of Segregation and Discrimination:

Under the Jim Crow Laws, there was segregation between Whites and Blacks with respect to the following aspects:



Such kind of a law was enacted when Rosa Park refused to give her seat. Moreover, such laws were not implemented in the So North, but in the South.

• The Bloody Sunday and Civil Rights Movement:

When a Black activist was killed by a white police officer, people started to march against the inhumane act. According to the book, "A short History of the United States", around 600 people marched and the dissenting voices were shut by ~~shelling and violent~~ ~~beatings~~ initiated by the American police.

Role of Courts and States:

• Harry Truman and Segregation Laws:

Harry Truman was among the first Presidents to realise the civil rights of Black. He tried to establish a civil rights committee but it was opposed by Southern Democrats. However, after the incident of ~~Rosa Parks~~, the Supreme Court of ~~US~~ declared the Segregation law as unconstitutional.

- **The Little Rock Nine Incident and Supreme Court of the US:**
Enumerate factors properly

Before the incident, the Segregation laws were ~~made~~ declared unconstitutional. When Black students from a school in Little Rock Nine were nominated to join the **Central High School**, they were threatened by a mob and then **Eisenhower sent federal troops** to protect the Little Rock Nine. In case of the school even, the **Supreme Court** declared the Segregation laws as unconstitutional.

- **Civil Rights Act and Dwight D. Eisenhower:**

After the incident, Eisenhower established a **Civil Rights Committee** to stop Segregation and give voting rights to the Black people. However, even after the incident, Black Civil rights movement continued and people were given rights by the time Cold War's detente period was about to begin.

• Civil Rights Act 1957:

When Lyndon B. Johnson became the Prime Minister of the US, he signed the **Civil Rights Act** and it aimed to prevent any oppression against equal voting for both Whites and Blacks. The **Civil rights act** also aimed to end **discrimination** in hotels, as well.

• Housing Act 1968:

Another step taken to emancipate Blacks was the introduction to **Fair Housing Act 1968** in the constitution of the US. This prevented **discrimination** for in buying properties and houses. It was the last Act and civil rights movements came to an end.

Conclusion:

The Civil Rights movement was accompanied by **brutal attacks** as well. However, after **Martin Luther King** got assassinated, **Black** people in the US got their rights back. &

Unluckily, the US sometimes still faces discrimination against the Blacks. In 2020, ~~for~~ George Floyd was humiliated by the police and got killed which triggered the emotions of Black people. Hence, it shows the apartheid system which, to some extent exists in the US. Martin Luther King said:

"I have a dream that my fair children will not be judged by the colour of their skin, but by the content of their character."
