### Introduction:

'Sex' is often very interchangeably used with the 'gender' but both vary drastically in their context. As sex is a physiological and anatomical characteristic whereas gender is a social construct imposed by socio-cultural factors including the society, culture, religion and even larger structures. One is born as a female or male but learns to be feminine or masculine. Thereby, prior is essentialist in nature whereas gender is constructive. Judith Butler in her book 'Gender Trouble: Feminism and Subversion of Identity' sheds upon this gender performativity as an 'act' rather than a 'being'.

But interestingly unlike gender, sex isn't fluid in nature as God clearly demarcates the line between both - he series through 'XX' and 'XY' chromosomes.

Sigmund Freud who is a widely acknowledge psychologist encapsulates the essence of sex in the following words:

"Anatomy (sex) is destiny."

## Biological factors:

In the present day world when man is questioning every eternal truth; it's natural for him to put a question mark in front of his own sex and to ponder over its fluidity. But just like some natural phenomena or catastrophes which occur regardless of any reason, giving the impression of some eternal power controlling it, sex falls under the same umbrella. Constructionists like often tried to challenge the construction of sex through science. Sex Reassignment surgery is a vivid example of it. In this surgery, surgeon attempt to change the gender of the person by either constructing a female's male genitalia or a male's reproductive organ is cut off. But some researches have proven that despite of the surgery behaviors are natural instincts are often observed in one's natural sex i.e. 'the urge to urinate like a man' even when one has changed her gender to a female has remained eminent.

### Case study:

As recorded by a sex psychologist from University of Kent; In a house in California two twins were born to David and Kate. Both were boys. On the parents desire to have a daughter, doctors reassigned the gender of one boy. On growing up, all

his life even in those flamboyant clothes and makeup, he simply did not adopt himself like a girl from within. Later on being revealed that he was born as a boy, he was relieved and changed his gender back to a boy.

### Human body and its social construction:

Human body itself is a proof of sex being a biological thing rather than a social construction. Constructionists argue that labelling women as 'sensitive' and men as 'rational' is merely a construct and not an eternal truth. Whereas, science has proven that the rationale behind women being sensitive is that naturally men use their left lobe of brain four times more than women. The left lobe of brain is responsible for the cognitive and rationale decisions, on the contrary right side of the brain responds to the emotional stimulations.

→ **Chromosomes:** naturally, women carry XX chromosomes, on the other hand a male is a carrier of 'XY' chromosomes. which builds up on the stance - that male and female are made on respective physiological aspects differing from each other. Restricting the whole biology to social construction is hence an understatement.

→ **Hormones**: The hormones which are released in a man is 'testosterone', and the hormone being released in a female is estrogen. While it's observed by medical researchers that male hormones are responsible for violent and aggressive behaviors i.e. anger. The reason why a male using intoxicants is seen doing violence against women is because of the high number of testosterone being released in his body.

**Anatomy is Destiny**: The symbol to refer to the sex of a female is ♀, as the symbol to refer to a male is ♂. Poststructuralists however embrace the ambiguity by introducing the genders which are either none or an amalgamation of both "androgynous" via symbol ♀!.

Sigmund Freud, like the essentialists negate this "in-betweenness" and clearly advocates sex's characteristic of being natural through his adage:

"anatomy is destiny".

Freud is globally known for his researches on humans and his all time famous theory of Oedipus complex. In which he illustrates the phallic age which lasts between 3-6 years and its implications on both the sexes.

As boys according to him feel attracted to the mothers and develops an envy against the fathers. Symbolically, because fathers have a 'penis' like them which leads to them developing a castration among them. Whereas, girls in the phallic stage go through 'electra complex' in which they develop a penis envy against 'male'. On feeling threatened of the penis, they attach themselves to the father as a "defense mechanisms" working against the penis envy. Freud this way explores the "unconscious" to which he refers as the 'tip of the ice-berg'.

Hence, this way Sigmund Freud also encapsulates the biological construction of sex. He deepens the binary and their heteronormativity because, to him sex is not something which is socially constructed but physiologically.

## Conclusion.

In summation, with all the advancements and industrialization man has ventured on this journey of denying everything while embracing the ambiguity. This is the very essence of modern day man, but like some other truths which exist out there without making any sense the biological construction of sex is also among those eternal truths.

Mainstream feminist approaches reject the idea that gender inequality is natural. D/W between liberal, social and radical feminism.

### Introduction:

From ecofeminism to the mainstream feminism there are different types and definitions of it. In Africa, feminism is the fight against female genital mutilation, In Europe it is an emancipation of witch-hunt, In Pakistan it is a liberalization of women who are often viewed as the 'enemies of men'. Hence, there is no monolithic definition of feminism. But on a birds view, it is an economic, political, social movement for the women, by the women and to the women. All the feminists across the globe agree: "That women are suffering".

### Background:

The roots of inequality goes back to the time we hold the record of. A critic Mary Ritter claimed that male critics throughout the history have viewed women as an "erotic species" or a marginalized "other". She writes that male historians did not take the

record of female history to mere account. As virgin wool captures this discrimination in the following words:

"This country is not a place for a woman"

This cry of her is an echo of her wounds which could never reach the male ears because of their entitled behaviors and derogatory attitudes. Her brother went to Oxford university while she was denied the basic formal education. Women writers were not even allowed to write their own pieces of writing from their names, in fact using a pen pseudonym was obligatory. The behavior towards women can be captured through the words of Aristotle who was a well-read philosopher in Greece "Women are like the deformed men". Plato building up on this said, "Women are made from the inferior men".

In a world like that where women were denied the basic human acceptability towards being a woman, it took a long journey for feminism to reach where it is today.

Suffrage Movement: Suffrage movement was an attempt of women to demand the right of vote and property rights. It's captured as the feminists' first big win, in documenting that gender inequality is not natural. Through Seneca Falls a formal meeting was called which was joined by 65 women and 13 men. It leads to the 19th amendment in America.

### Civil rights Movement

It's critical to note that women who were granted the right to vote were predominantly white women (not the slaves or black women). Europe in those times was a brutal aftermath of European colonization, which in the name of mission: "Civilizing them", entirely exploited them and aimed to change their race by dehumanizing them. The captures the essence of liberal feminists in the following words:

"I don't want women to have power over men but over themselves." - Simone de Beauvoir

### Case study of Pak.

In Pakistan, Aurat March is often criticized for the demands it put forth by the placards, which include slogans like 'mera jism meri tarzi'. It is a demand to ascribing complete autonomy over ones body. It has sparked a lot of controversies in the country. Another slogan which has triggered the patriarchal mindsets is 'Apna khana khao garam kro'. It is another claim of feminists against the historical ritual of females making and heating up the food for the men of the house. Both of these demands are of radical feminists, who majorly them of men as a problem and a hindrance in their emancipation.

### Introduction:



Throughout the history man has been seen as a defensive - social animals who tends to use two main approaches in the situation of threat and this 'Fight or flight'. History has witnessed him using the prior more than latter. Back in the days of hunters and gatherers, man used to kill his enemy to save his life expectancy and it also got stronger and stronger in his instincts with the Darwin's theory of human evolution, in which

Different theories: Different theories by various analysts have given violence varying lens, some magnify it and some minimize it but all the theories provide with a logical reasoning of violence which takes place.

**(1) Biological Theory:** In the light of biological theory, the intervention of biological aspects are often used to make sense of the violence which has taken place. For instance the hormone of testosterone in men is often used as a justification to mask the violent behaviors of men. Literature is filled with the male centric view of men justifying extra marital affairs using their biology and when women would relate, they are often seen indulging in aggressively violent behaviors to shoo them away.

Example: The example of pakistani model and social media influencer Qandeel Baloch who was

murdered by her brother in the name of honor killing is often justified as his 'honor' on which his male ego did not allow him to tolerate what his sister was doing.

② Medical theory: In this theory medical reasoning is provided to view the violence from the lens of a medical personnel i.e 'A doctor'. Psychologist who diagnosis OCD "Obsessive compulsive disorder" or some medical sickness in the culprit which provided him to act violent.

A 'retard' who is not sane is prone to inflict some kind of violence on anyone, such cases are often met with less severe consequences because the PPC requires for the culprit to be 'sane' in order to be held accountable for his ordeal.

③ Feminist theory: This theory views violence as a result of entitled and prevailing masculinity which gives men the authority to overpower women in their capacity. In this approach the violence is being inflicted on one primarily for being a woman. Marriage in conventional societies is seen as a licence to get as violent as one wants to. In most of the cases the crime is done by a father, husband or a relative. Studies show that rape, honor killing,

are the crimes which are 85% committed by a close relation.

Example: The case of Zahra Baloch who was brutally cut into pieces by her husband and then hung on the ceiling fan makes an example of the domestic violence which takes place in scores and mostly go unregistered because in South Asia such violences are considered as a 'private matter'. The constitution not acknowledging 'marital rape' as a crime is a living proof of that.

### → Prevailing Form:

In Pakistan the most prevalent form of violence is undoubtedly 'domestic abuse'. A survey conducted by APWA in 2024 showed the number of violence against women in Pakistan was around 39,400 among which 20,314 cases were of domestic abuse, which is predominantly seen in the provinces of Sindh and Punjab.

It's ironic that Pakistan was among the few countries to sign the 'CTDAW' in the very first meeting. It has the following laws promulgating in the favor of women but all in vain.


