Apart from this, certain strategies like the provision of equal opportunities to women and the eradication of gender-based discrimination can end the notion of woman's fragility. Hence, the biological differences and conservative ideas present women as a fragile creature. However, the participation of women in politics, science, and literature has debunked this myth.

Before exploring the underlying causes of women's fragility, it is pertinent to understand the notion of women's fragility. The fragility of women refers to weakness of women in performing certain tasks that are primarily associated with men. The conservative attitudes are credited with the creation of women's fragility. A renowned feminist author, Simone de Beauvoir, has argued that "One is not born, but becomes a woman" [The Second Sex]. It means that the nature has not created woman as a fragile creature but the conservative ideas of the society has converted woman into a fragile creature. Hence, the fragility

of women is the result of social attitudes.

Firstly, the Conservatives describes biological differences for proving the fragility of women. According to these difference, they argue that God has created men and women for performing a reproductive role. Unlike the muscular strength of men entails that they have to perform bigger tasks. Moreover, women can not perform certain tasks due to her different biological structure like having specific days. Unlike the other hand, men are not constrained by these limitations. It is believed that women do not have enough mental capacity in comparison to men. Resultantly, they can not perform the jobs involving mental performance. ^{For instance} there are only seven ^{females} out of one hundred and twenty six judges in Pakistan. Moreover, there is not a single female holding the office of Attorney General of Pakistan. (Justice and Law Commission report, Islamabad). Therefore, the pre-conceived notion of women having less mental capacity making women a fragile creature.

Although, the conservative ideas present women as a fragile creature, the participation of women in different areas has deconstructed this narrative.

First comes the role of women in politics. Many women have played a vital role in political field along with men. The example can be taken of Pakistan movement. The remarkable role of Fatima Jinnah and Begum Shaista Ikramullah can not be ignored. As far as the

The role of Fatima Jinnah is concerned, she stood shoulder by shoulder with her brother Quaid-e-Azam. Apart from this, she has struggled against the dictatorship of Ayub Khan. Hence, the political role of women indicates that women are not fragile.

In the same manner, the role of women as successful administrators has debunked the myth of women fragility. It is often believed that the men are the only good administrators. However, the administrative role of Razia Sultana, an Indian Princess, is historical achievement of good administration.
