For example, the World Health Organization coordinates efforts to combat pandemics such as Ebola and COVID-19.

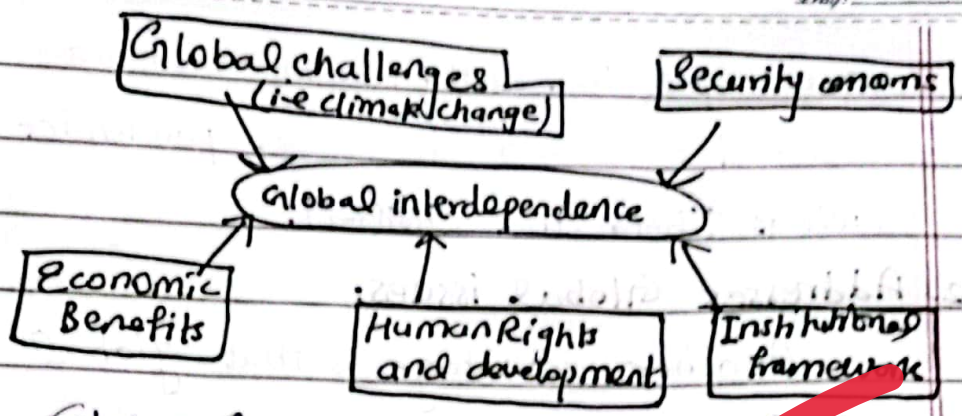
2. Addresses Global issues:

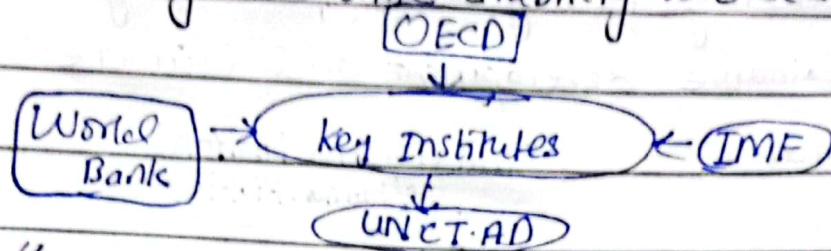

2. Economic Cooperation

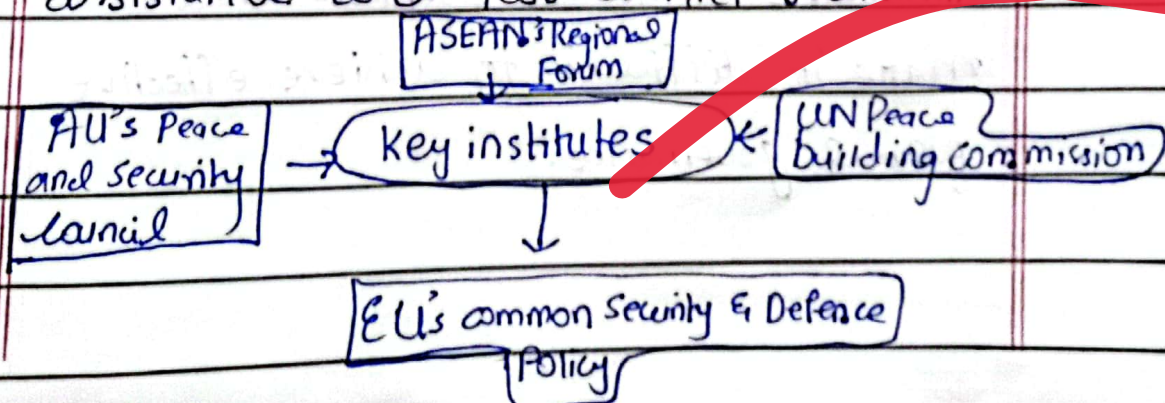
Global governance and institutions play a crucial role in economic development by providing financial support and investment, by promoting trade and enhancing economic stability and security.

3. Security Concerns

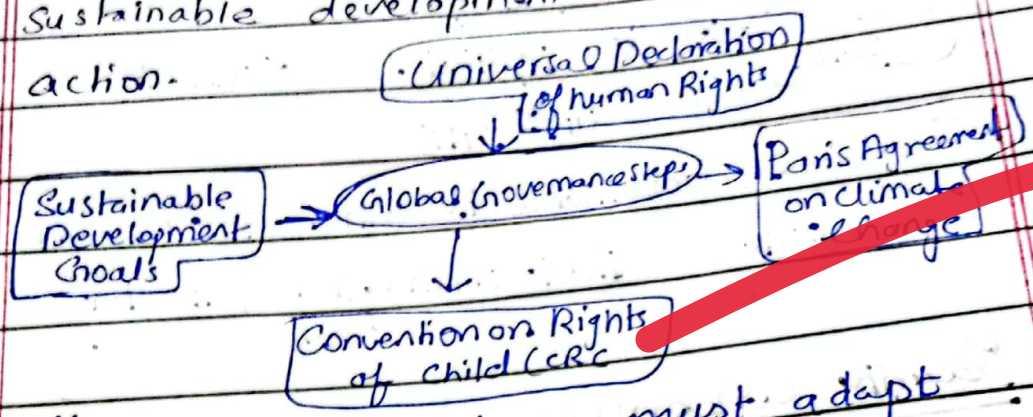

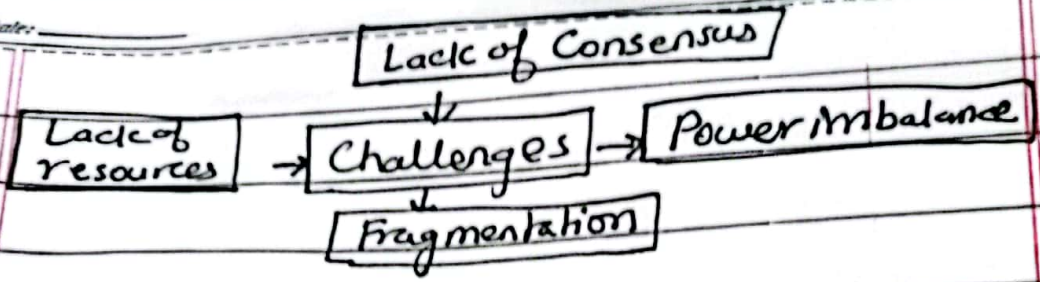
