### 3) Forms of Gender-Base Violence Against Women in Pakistan:

#### i) Domestic Violence:

Domestic violence is the most prevalent form of gender-based violence against women in Pakistan. It includes physical, emotional and sexual abuse by a spouse, partner or family member. It is a widespread problem, and a survey conducted by Human Rights Watch found that about 90% of women in Pakistan experienced some form of domestic violence.

#### ii) Honor killing:

Honor killing is another form of gender based violence against women in Pakistan. They occur when a woman is perceived to have brought shame to her family by engaging in a behaviour that is considered immoral and inappropriate. The punishment

### iii) Acid Attacks:

### iv) Forced Marriages:

Forced marriages are another form of violence against women in Pakistan. It is a practice where a woman is married ~~again~~ without her consent or against her will. This happens when a family of women ~~are~~ are unable to provide dowry or when the woman is seen as burden.

Sexual harassment is a wide spread form of GBV.

According to "US-based National Library of Medicine 2023, about 54.5 pc women in Pakistan experienced sexual violence. Women in Pakistan face sexual violence at homes, public places, work places and educational institutions.

#### vii) Child Abuse:

Child marriage is a prevalent form of violence against women in Pakistan, with girls as young as nine being forced into marriage. This deprives them from their childhood and education and exposes them to various forms of Abuse. 21 percent of girls in Pakistan marrying before the age of 18 (UNICEF 2020).

#### 4- Strategies to Eradicate GBV from Pakistani Society:

To eradicate Gender-based violence from Pakistani society,

there is a need to implement a multifaceted approach that addresses the root cause of problem. The following strategies can be helpful:

### a. Awareness Campaigns:

One of the most effective strategies is to launch awareness campaigns. The government should collaborate with NGOs and civil organisation to educate people about the harmful effects of gender-based violence on women and society as a whole. These campaigns should be aimed at both men and women to change the attitude and belief that perpetuate Gender-based Violence.

### b. Strengthening the Legal Framework:

The government needs to strengthen the legal framework to protect women from Gender-based violence. Law must be enacted and enforced to hold perpetrators accountable for their actions. Special courts should be

established to expedite the trials of Gender-based violence cases.

### c. Empowering Women:

Empowering women is crucial in eradicating Gender-based violence from Pakistani society. Women need to be educated and given economic opportunities to become financially independent. This will help them to escape abusive relationships and will have more control over their lives.
