Therefore, interests are eternal and perpetual objectives.

Nation states have been assisting one another against climate change. The critics ascribed that countries are helping without pursuing interests to combat climate change. Sadly, the stance of critics does not match the reality. Nation states do not assist one another in the fight against climate change. Nations responsible for huge emission (CO<sub>2</sub>) such as U.S, Russia, France, China and India have never assisted the affected countries. G7 powers have never respected the features of COP 26, 27 and 28. Therefore, the critics stance is illogical and nations are following interests.

Investment is being carried out without interests. Critics say that countries such as U.S, China and EU are investing in underdeveloped countries without interests. Moreover, the opponents say, the aim of the invest is to contribute to prosperity. Interestingly, critics lacks knowledge about the globalization. According to Reuters Report 2023, A Canadian mining company (BARRICK) has exploited the natural resources of developing nations. Major economic powers such as U.S and China are also exploiting the developing countries by the name of investment. Thus, critics know nothing.



Humanitarian aid is being provided to nation states without interests. The critics ascribe that nations such as U.S has been providing aids to affected nations without interests. According to critics interests are not everything in the world. Countering the critics stance, U.S has recently banned providing funds to Palestine based aid agency. The agency known as UNRWA. This shows that U.S follows interests. Thus, interests are the most important aspects of international system.

Nation States have been boosting the health sectors of one another. Critics say that countries have been boosting (healthcare of one another without interests.
