Radical feminism and Socialist feminism were two of the ideologies that emerged with the aim of understanding and tackling the issues of women efficaciously. Socio-cultural, Economic and Political Demands:-

Definition of Socialist:

It is one step advance to Marxist feminism. Socialist feminists believed that along with "Classism" the women are suppressed with also "Sexism" and that is deeply rooted in our societies.

Sexism → Society is divided in sexes.

* Socialist = Marxist + Radical
= classism + Sexism.

Goals of Marxist feminism:

Marxist is the antithesis of capitalism. people inspired by Karl Marx they believed that in capitalism, the more resources the more influence in the society which creates huge difference between the haves and have not. And,

this is the reason women are exploited in the society as our society is mostly patriarchal and resources are in the hands of men.

So must replace this classism with socialism.

- classism → Because of Capitalism, there is privatization of resources.

- Socialism means nationalization of resources. Everything is owned by the State and this creates equality in society.

Economic, Political and Socio-cultural Demands.

Feminists devoted their activism to fighting for the inclusion of the domestic work within the waged capitalist economy. The idea of creating

Compensated reproductive labor was present in the writing of socialists such as Charlotte Perkins Gilman (1848) who argued that women's oppression stemmed from being forced into the private spheres.

Patriarchy Vs Capitalism:

Radical feminism focuses on how the prevalent patriarchal structures in the society propagate a system of discrimination against any gender that is not male. While socialist feminism talks about how the capitalist system creates a class system where the bourgeoisie are male and proletariat are women and the bourgeoisie exploit the proletariat because they own means of production.

Change in Society Vs. Change in economic system:

Radical feminists seek to bring change in the society at large by overturning the current system of beliefs and establishing norms that would treat women and other gender equally. On

the other hand socialist feminists want the change to be focused upon the economic system. They believe that if women are provided with equal economic opportunities, their position in society will be elevated automatically.

Gender stereotyping vs. Economic Subjugation:

Radical feminists believe that the socially constructed gender stereotypes help to enforce a system of discrimination and there should be an end to this stereotyping. Contrary to this, socialist feminists believe that an equity based system should come into place where women should be rewarded according to the production done by them and that the class system galvanized by capitalism should be eradicated to give women equal rights.
