The Resolution guaranteed the protection of



Fundamental human rights, including the right of freedom of speech, religion, assembly, and equality before the law. This ensured that civil liberties be protected in future constitutions.

#### 4) Guiding Future Constitutions

The Objectives Resolution served as a guiding principle for the Constituent Assembly as it framed Pakistan's first constitution in 1956. It was eventually adopted as the preamble of the 1956,

1962, and 1973 Constitutions. In fact, it was made a substantive part of the 1973 Constitution through the Eighth Amendment in 1985, cementing its role in Pakistan's constitutional history.

For example, the 18<sup>th</sup> Amendment of the 1973 Constitution affirmed Pakistan's federal character while preserving its Islamic identity.
