These steps include ending patriarchal mindset, educating women, and treating all genders equally. Thus, unequal treatment of women in society entails that gender equality still remains a myth. However, some careful steps can effectively convert this myth into an undeniable reality.

Complexities of gender inequality, it is pertinent to explore the hidden meaning of gender equality. This term refers to the equality of all sexes irrespective of biological distinctions. According to UNICEF, gender equality refers to a situation where all boys, girls and transgender children enjoy equal reputation and respect. Therefore, the discouraging women in educational sector, enhances gender inequality.

Similarly, women have limited opportunities in politics. Only the women of influential families get access to politics. The common women are confidentially discouraged from joining politics. A renowned author Tehmina Durrani has argued that women are discouraged from joining politics by their male counterparts. [My Fardal Lord]. Moreover, the cabinet of Prime Minister of Pakistan, Shehbaz Sharif, includes only one woman minister. This indicates gender disparity in politics. Hence, limited opportunities for women in politics prove that gender equality is a myth.

Additionally, women are not preferred for high level jobs. It is due to misconception that women have less mental capacity than men. Resultantly, they are unsuitable for high profile jobs. For instance, all the CEOs of major multi-national

corporations are men. Moreover, it is a rare incident that a woman is authorised to supervise any department single-handedly. Therefore, discrimination against women in jobs also reveal that gender equality is a myth.

Also face Apart from this, transgenders face social discrimination. They are looked as inferior creature. Moreover, they face public criticism and harsh attitude of many individuals. Most importantly, transgenders are discouraged from pursuing jobs. Moreover, they are also restricted from living a respectful life.
