As per report by Center for Strategic and International Studies (CSIS), the report highlights that US views CPEC as a strategic tool used by China to extend its economic influence and geopolitical influence in South-Asian region. Furthermore, US perceives CPEC as a strategic move to create dependencies, alliances and to shift the regional from traditional US influence. This perception is grounded in the concern that China through CPEC will undermine US economic presence and geo-political strategy in the region by
