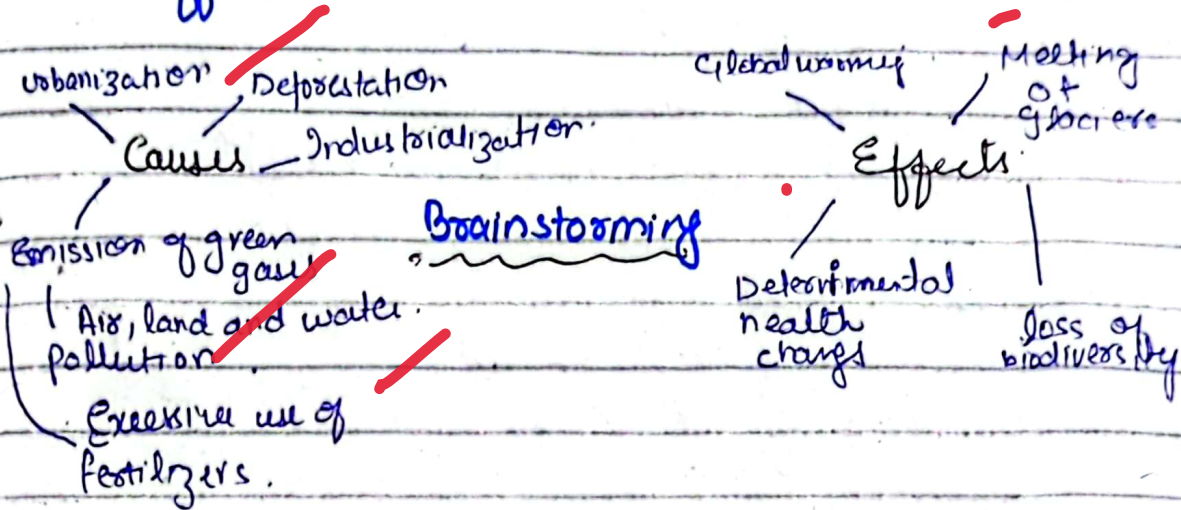

a) Urbanization

• Unsustainable reliance on coal and power plants

• Urban heat island effect

• Overpopulation and excessive transportation

We can define urbanisation as rapid urbanisation or intense deforestation
