This is a question often coming on the minds of those on witnessing justice being delayed. However the suffering party does not have the energy to ponder over it as it is too tired of fighting their case and eventually surrendering, believing that justice delayed is justice denied. An offence is itself an injury as law declares it and justice in the light of law is the compensation for that injury. But the delay in that justice is indeed like another, equivalent to stabbing the victim twice. However it is worse than the first offence because the second offence is caused by the law making body itself i.e. the supreme court of Pakistan. The antonym of justice is injustice but between the two lies the silent antagonist which is the delay in justice. The very basic and centripetal laws embedded in the preamble of every constitution is the 'right to live', and the second to it is the 'right to follow one's beliefs and religion'. The preamble of 1973 constitution of Pakistan, the constitutions of Britain and India have also penned it down very explicitly. But the real question of lawfulness arises when there is a threat to the rights provided by the state and the obligations imposed on the citizens on the name of law. The foremost injury to the justice happens when the provided laws are compromised and the obligations imposed by the state are not followed. The second injury however takes place when the code of law delays the act of justice. The countless cases in the history which did not make to the final trial are a living example of such delays. The aftermath of delay in justice is often confronted with the solutions like 'blood money' which is a compensation amount provided to the victims by the offenders to simply let go of the case. The bigger the case is, the more rise in the blood money accelerates and the trial the profile is the lesser of the compensation is.

instance may be called an 'independent' judiciary in theory but in reality the entire power falls into the hands of House of Commons, whose sovereign is the prime minister. Here the law is not above the prime minister. Unlike America, where judiciary is independent in its true essence, and is capable of overthrowing the president and the vice president as well.

Another contributing factor, the delayed justice is the poor infrastructure of the society.

Infrastructure is the body on which a structure stands, if it is poor and maligned the whole structure will simply collapse. Similar is the case in the domain of justice. If

the entire chain of jurisprudence starting from the FIR first information report to the final proceeding would not be standing on the grounds of just bodies governing and operating the whole case. There is no way that it would be able to meet the outcome of 'justice' provided on timely constraints.

For instance; the constitution of Pakistan declares murder to be an offence against the whole humanity. Lastly, another reason why the timely justice in the judicial proceedings are the overburdened courts, which are mostly observed in a poor country which lacks resources to hire enough man power. And consequently less number courts operate on the societal level which increases the number of cases and slows down the procedures violating the time constraint which is given for a certain case. In Pakistan only, according to survey by Law and Justice Commission of Pakistan released in the BI - Annual report 2020 mention cases are pending in the courts of Pakistan. All these cases are a living proof of a victim who dies everyday, the death of delayed justice and an oppressor who lives freely and more blatantly considering it a win and a slap for the other fighting for justice. Hence, justice delayed is another name for justice denied. Because justice and its provision is one of those exceptions where there is no tomorrow. History is the best preacher in this regard, it shows the countless innocents who became a prey to the prolonged and untimely justice inflicting them with an injury which was worse than any because it was the irreversible time. It's often said in the famous adage - that the bygone time does not come back. However its best example appeared in the human form of Nelson Mandela, who became the 10th South Africa's first black president but at the cost of his unlawful 27 year imprisonment. He was fighting against the apartheid existing as the deep evil in the south Africa's roots. As a result, he was imprisoned on the name of anti-nationalist. Later on completing his unjust imprisonment he did become the president but could only complete one term, age being a prominent factor in that decision. Similarly, the ex-PM Shuja who was hanged in 1979 became a prey to the delayed justice as the decision was declared by Pakistan court of justice after 44 years of his hanging declaring it to be an unfair trial in the murder case. Such precedents from history teaches the mankind the best lesson of justice, in fact more precisely the timely
