1- Introduction:

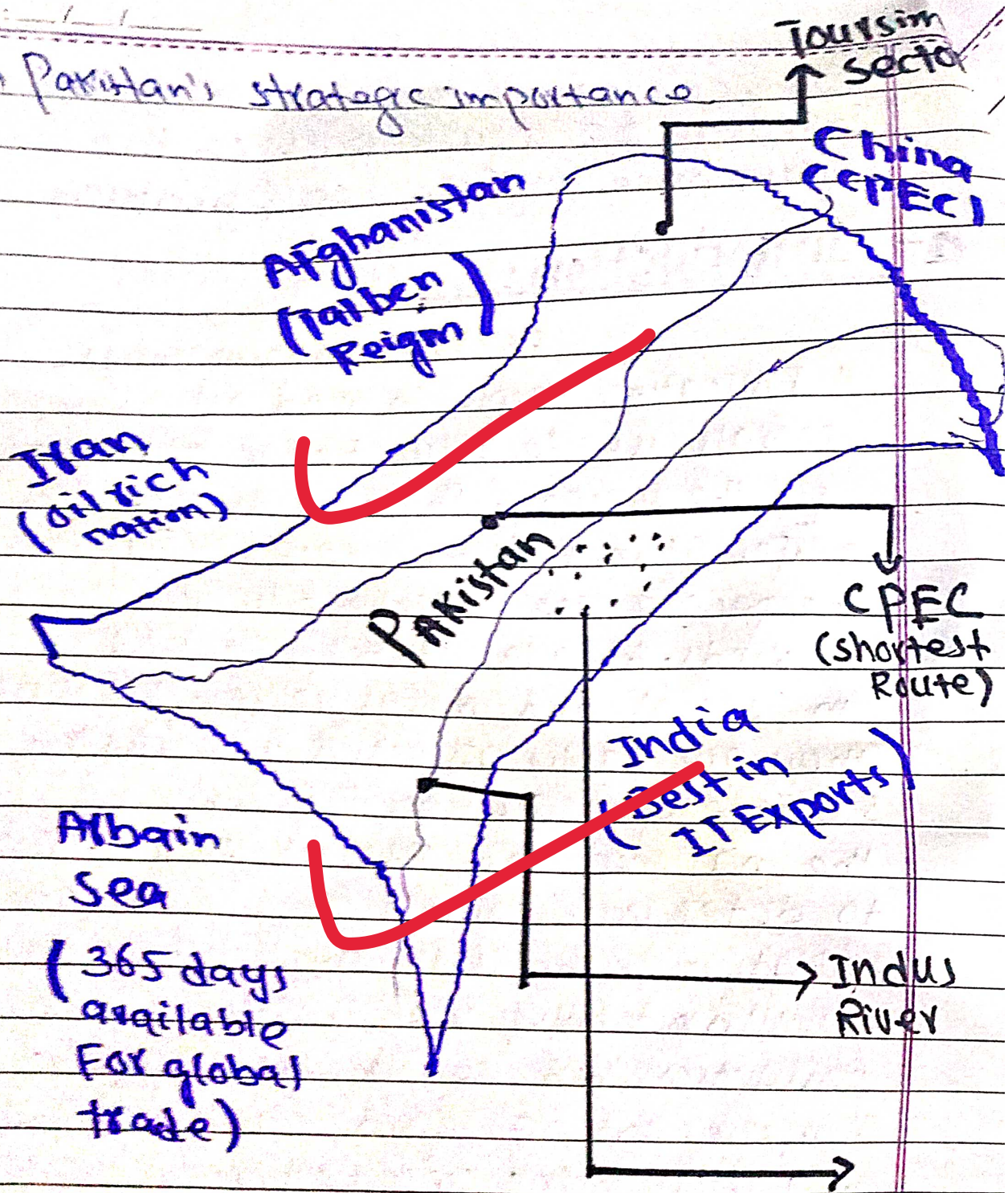

2. Involvement of Establishment → Involvement in Election, generating Leadership crisis and promote corruption.

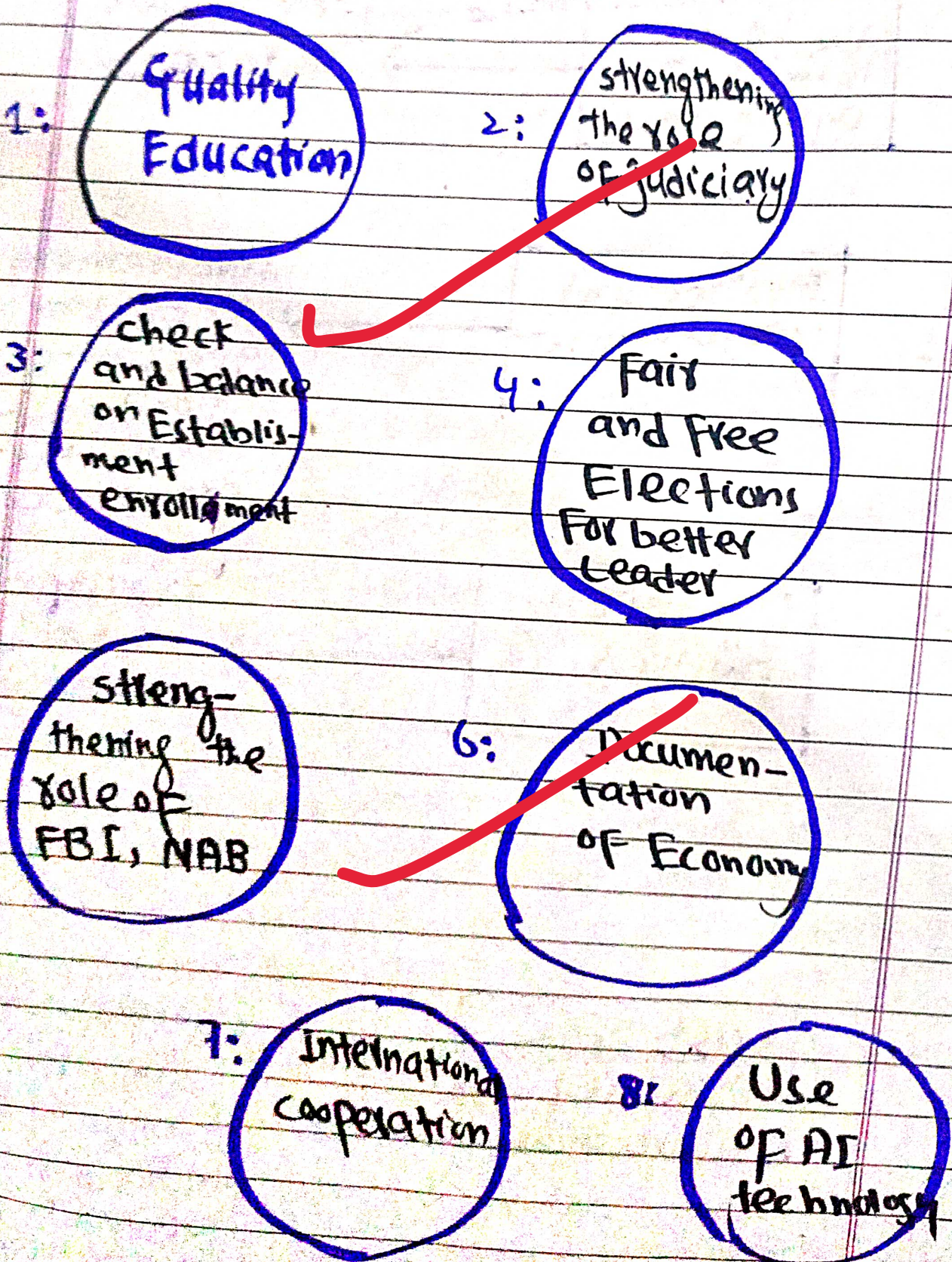
3. Dynastic politics → 'Pakistan a hard country'

4. Lack of Quality Education → general public Lack in Quality Education, as a result political parties use them for their agencies.

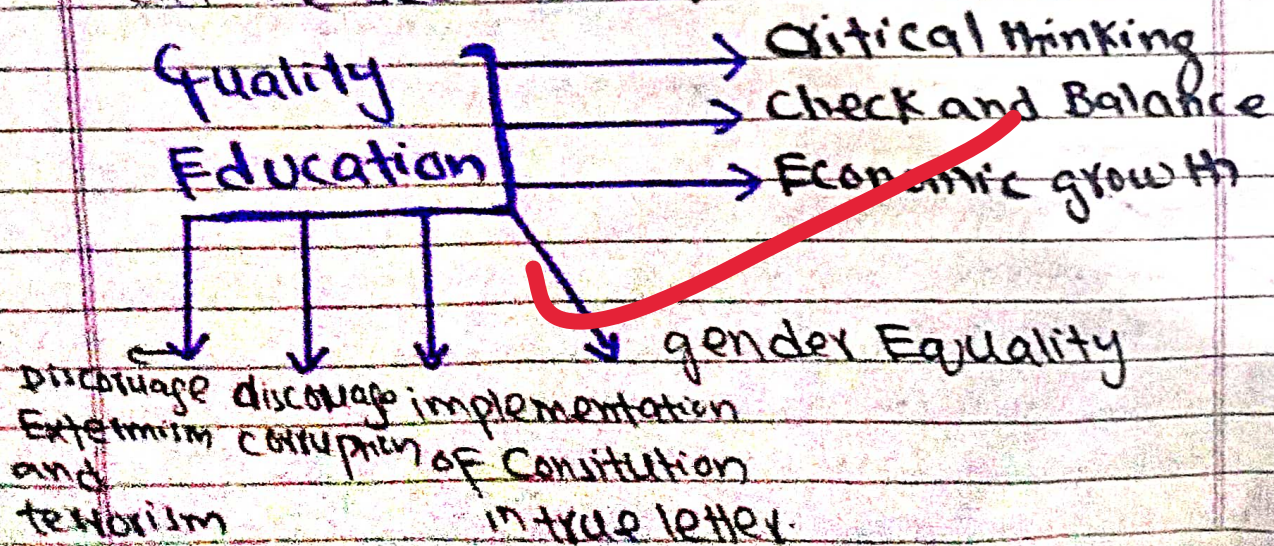

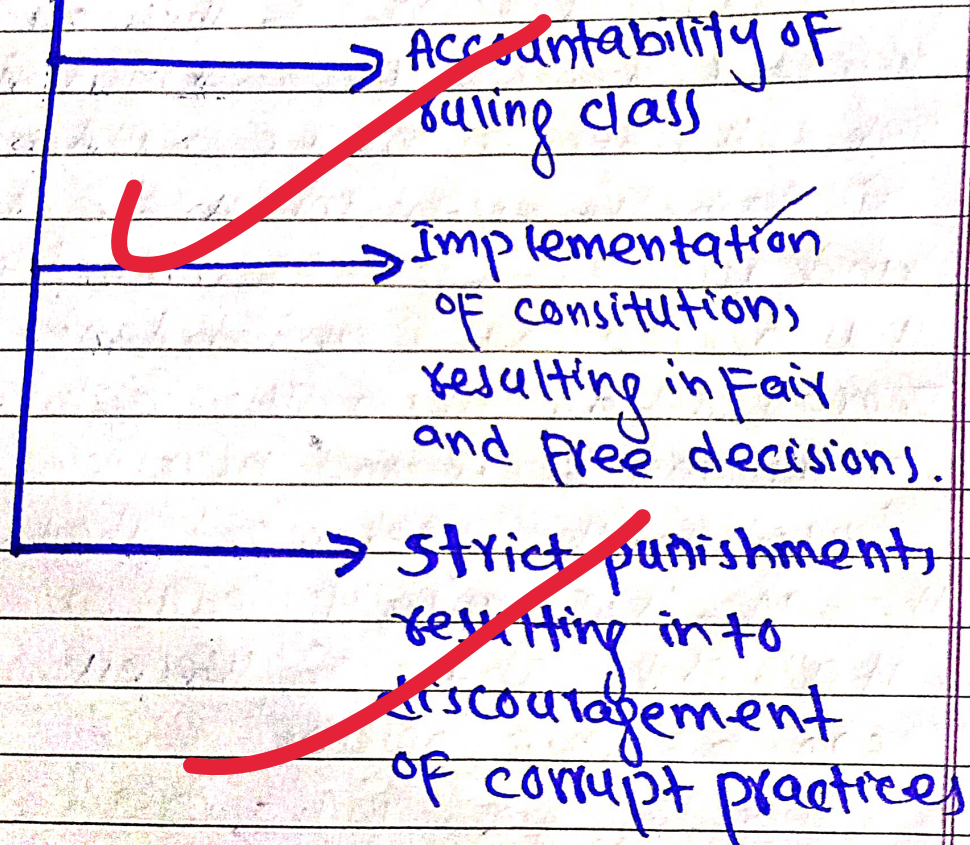
10. Access to the Quality Education:

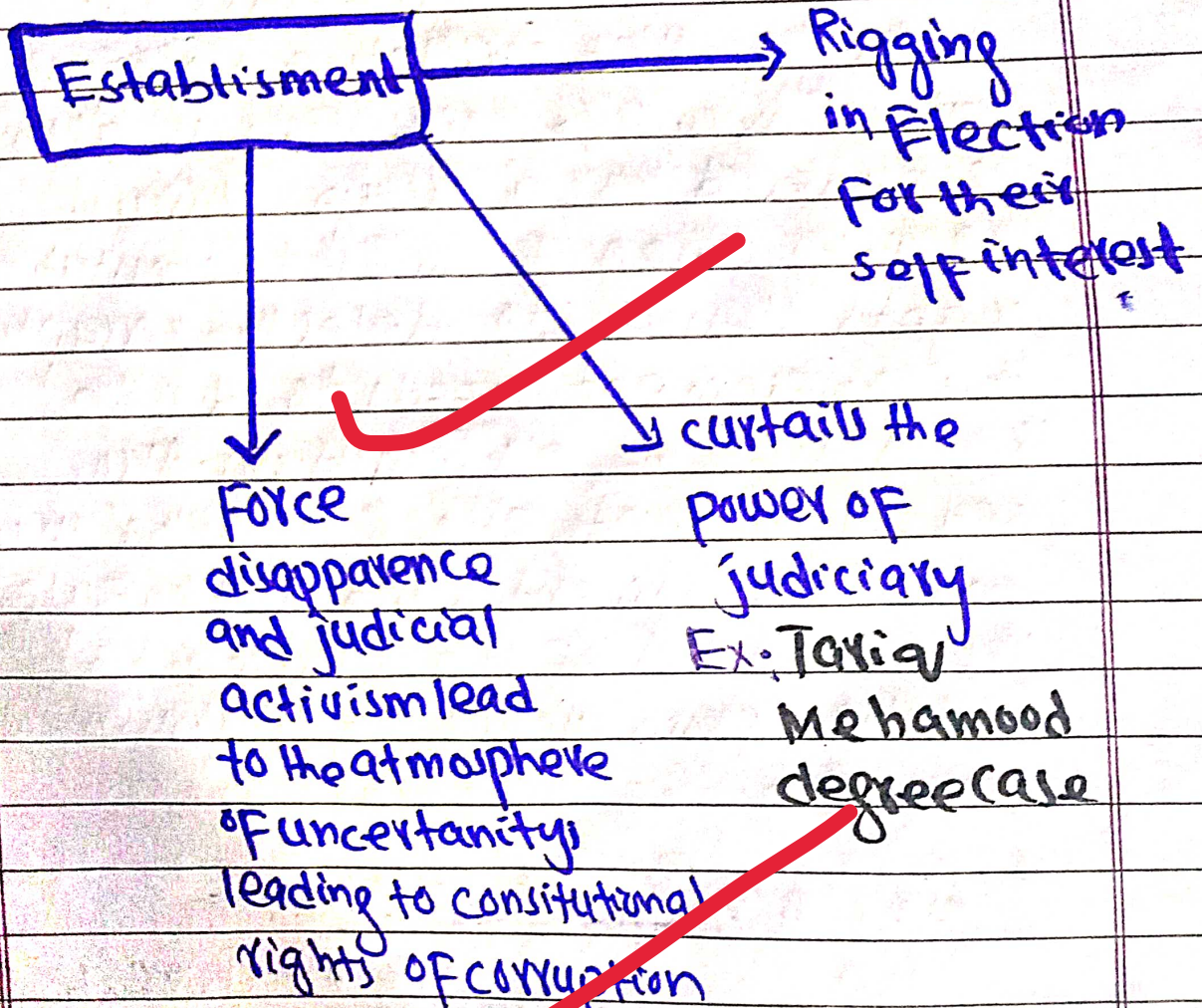

Solution:

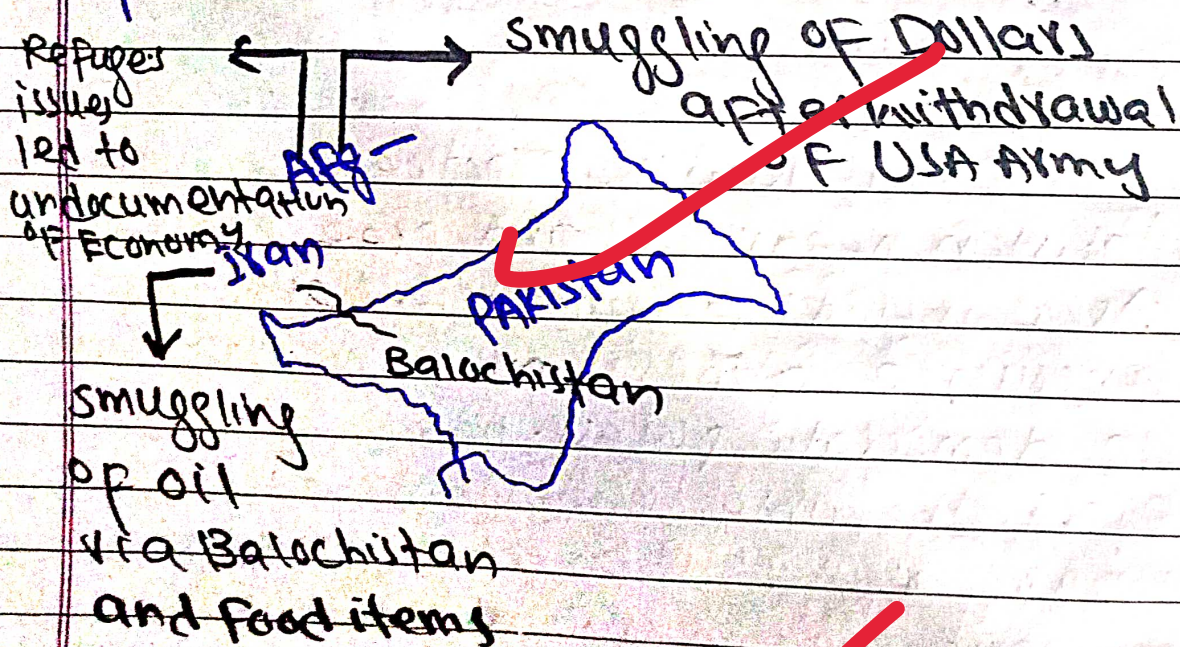

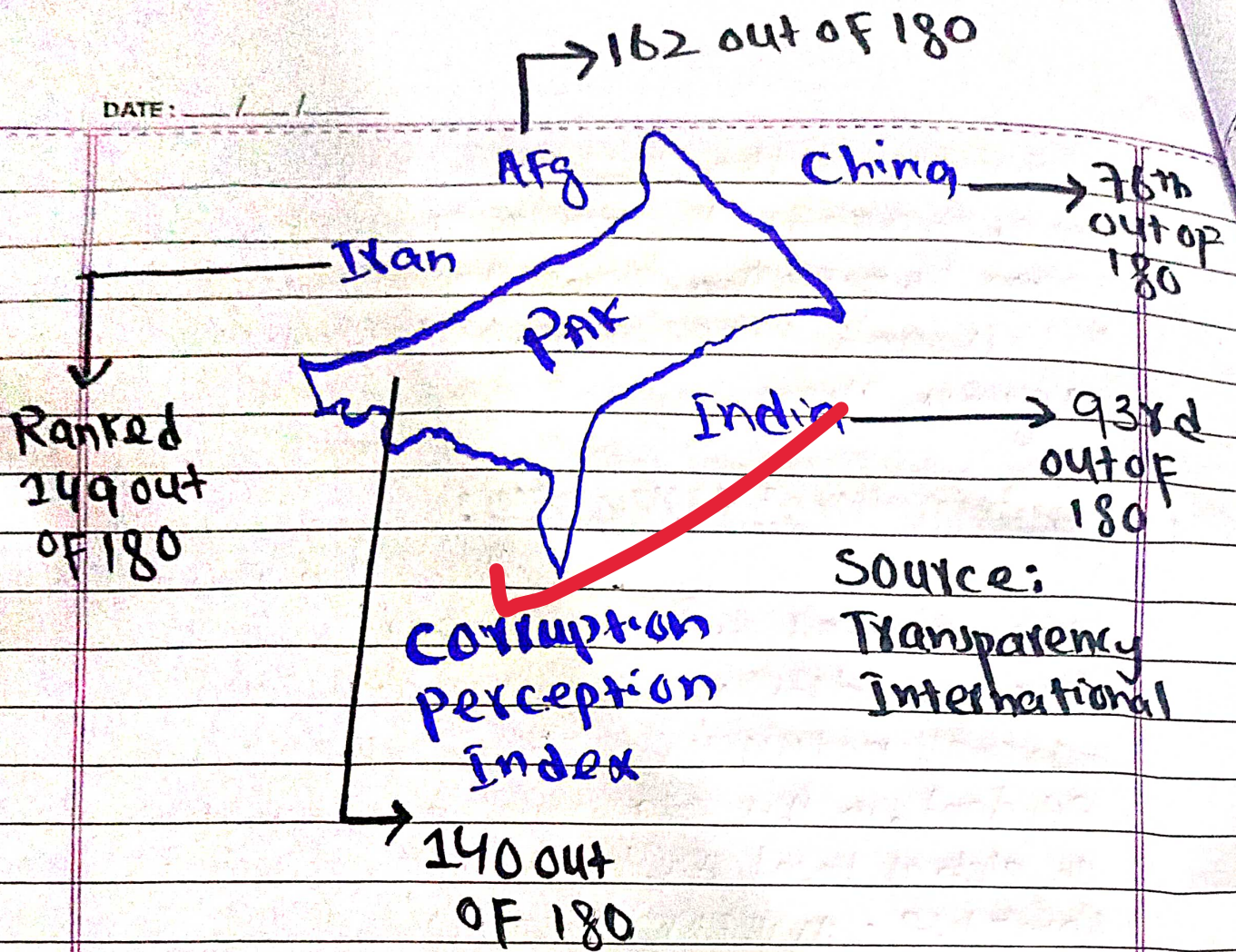
Therefore, to avoid the corrupt practice Pakistan needs to take a collaborative efforts with its neighbouring countries.
