2. Political Participation a Human Right

The Universal Declaration on Human Rights in its Article 21 accentuates that political participation is a human rights, and its necessary for both genders to participate in this.

Also, the same has been accentuated by international Convent on civil and human right - Article 25.

3- Obstacles faced by women politicians

3a- Social and Cultural Barrier

One of the major issue faced by women politician is social and cultural barrier. Pakistani society is a patriarchal society, in which women are often passive victims not active participants.

"In the book, Islam is a misunderstood religion the author highlights how in the name of religion women are often exploited."

3b - Violence and Harassment

Secondly, women who participate in politics often face violence and harassment.

"21% of the women who participated in politics face online harassment."

3c - Political parties

Reluctance

Thirdly, the leaders of political parties are often reluctant while selecting women as a candidate because of the Gender Norms.

"In 2018 general elections only 5% of the total candidates were women, indicating that political parties remain

hesitant to nominate women for general seats."

3d Lack of resources:

women are considered as "havesnot" i.e they are dependent on men. Thus women doesn't have the necessary resources to run the campaign. Also, as a candidate she needs to perform lobbying but the head of industry prefer men over them.

"As per the survey conducted by women parliamentary caucus, women often lack ^{necessary} resources to participate in politics."

4. Impact of Political Quota.

4a - Increase representation

The political quota has increased representation of women in National and provincial assemblies. For instance, women have reserved 60 seats in the national Assembly out of the 326 seats.

4b - Introduction of various women related bills.

The women participation has introduced various bills which will resolve women related issues. It includes dowry & bridal gift restriction, Anti-sexual harassment bill and domestic violence act

4c- International Recognition:

The increased women participation in politics facilitate the fulfillment of sustainable development goals i.e. SDG 5 - Gender equality.

4d- Empowerment of women

The introduction of political quota has allowed more women to participate in politics and make laws that will help to combat women related issues i.e. Gender based violence.
