Criminology deals with crimes.

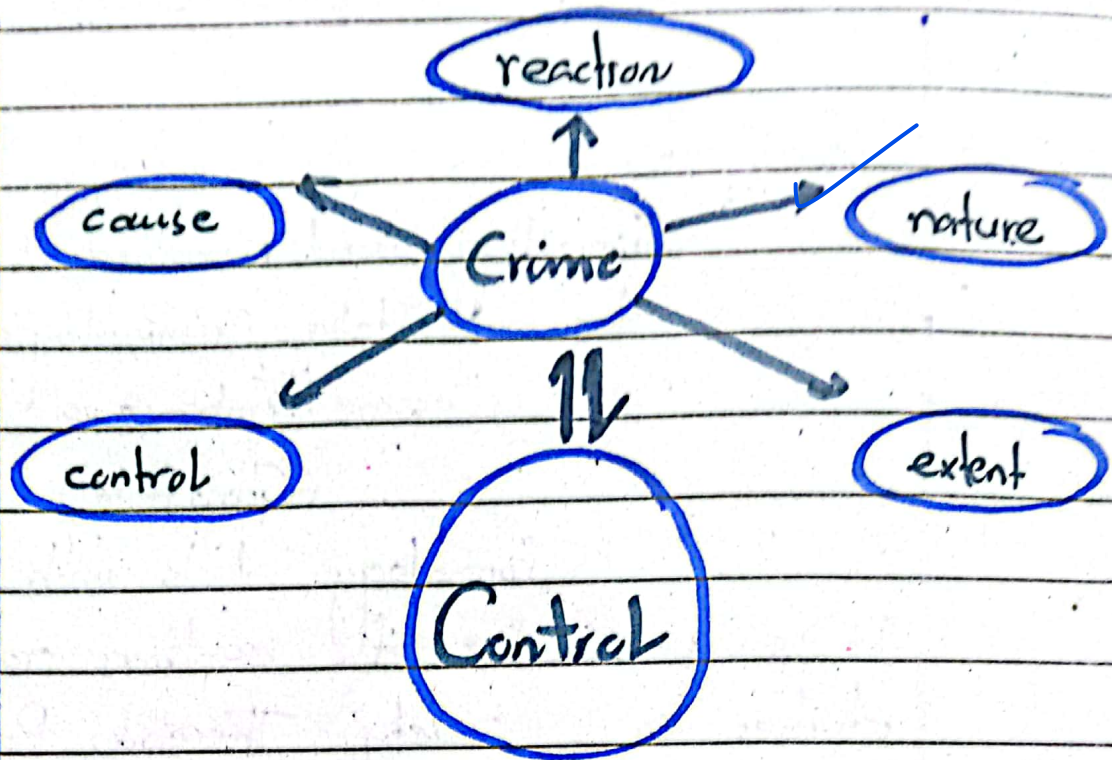
It is a science of curbing criminal activities in society. Thereby, Pakistan gives a huge respect to Criminology in order to reduce criminality.

Therefore, Criminology is study of crimes.

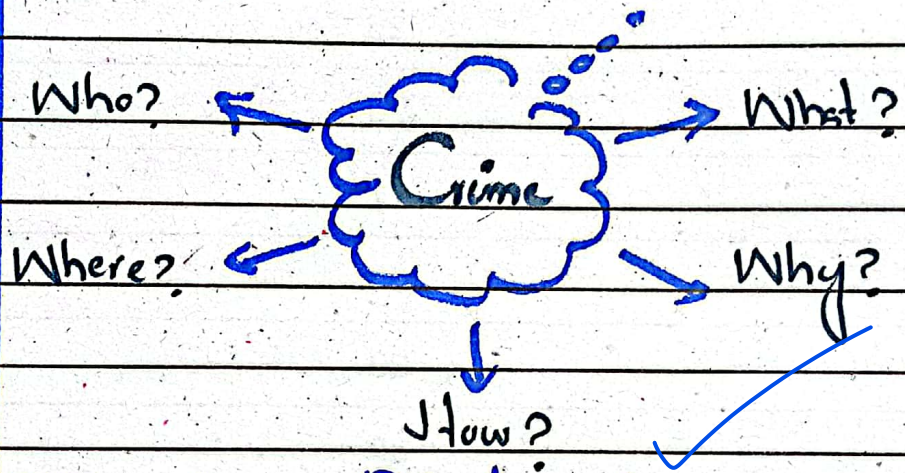
3- Scope of Criminology in Pakistan

(Susan Wilson - Crime Prevention)

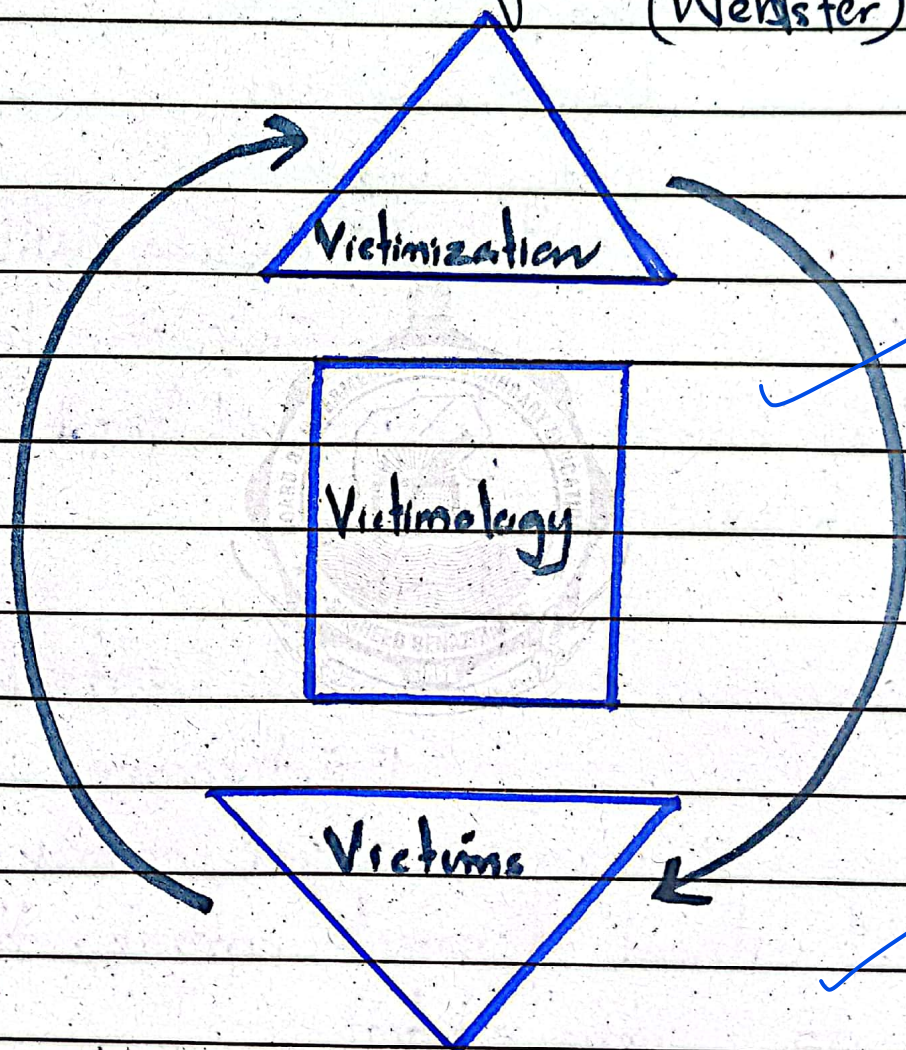


This shows Pakistan has concern with Criminology

Additionally, Pakistan also encourages socialist bond. In Criminology, socialist bond gives



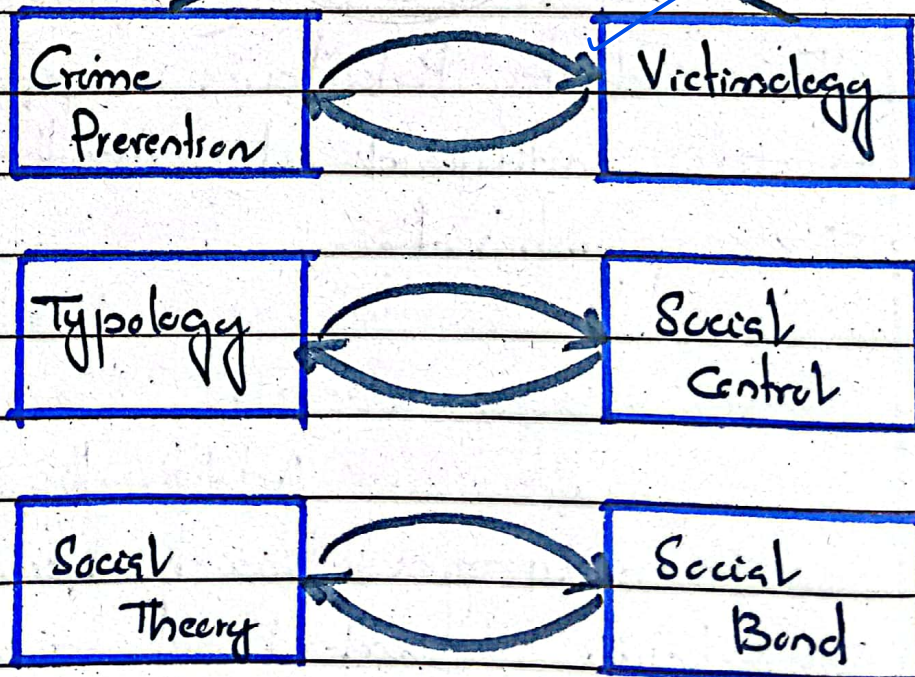
better understanding of crimes.
