The Colonial mentality intensely attached Pakistan until gaining independence in 1947. The British administration put indelible marks on social, political, economical structure on Pakistan. The Colonialism means slaves and master relationship. The Colonial mentality is to follow the attitude, value and principles that were ~~set~~ got by British administration. most of the colonial rules are also follow in Pakistan even today. Even political, judiciary, bureaucracy, military education are all work on colonial/British administration. it is

the reason that hindering the
progress of Pakistan. The
price of Pakistan rupees are
fall as the comparison of
Afghanistan currency. Because
there were no colonial
administration, where public
treated like inferior or slave
and ruler are master or
superior authority. Like the
part of sub-continent. at the
time of British era.

First came the bureaucracy
which works on the principle
of British principle. They enjoy
luxurious life, which is disregard
on the executive and on the
poor public. Despite heavy electricity
Bills, they enjoy free unit, which
shows the colonial mentality. They
are more privileged and
considered themselves above
law. For instance, the Rawalpindi
scandal of Ring Road, the DC

found involved in corruption.
They ~~was~~ sentenced by court
But next government not only
restored them but also promoted.
They know they are not
responsible for their autocratic
decision. For Example. DC
Islamabad issued many MPs
against famous politicians despite
the court order. Court sentenced
him due to the contempt of
court but he never landed in
jail. On the other hand had it
a common man, he has
suffered from the wrath of
institution. They know they
are immune to accountability.

Instead of protection they oppressed the public. The incident of Jallianwala in Amritsar where 1500 innocent people were killed by police. Showed Colonial mentality. The Police

used as tool of politics which show the inferiority of public and superiority of master. For instance. The peaceful protest of teachers handle in Pakistan. Moreover, the blind teachers were beaten in Karachi and Lahore through the beaten charge and water shells. In addition to incident of model town Lahore where many innocent women killed by police. The behaviour of police makes a huge gap between the police and public. The public are not agree to go police station for complaint or file FIR. Due to brutal behaviour of police. The horrible behaviour of police terrify innocent people. The incident Jalawala are the example of police brutal behaviour. People feel happy when the police victimize by other man. It shows

the gap between them Because
Police do not protect public
fundamental rights They work
as a machinery of state and
victimize the public.

The judicial system also shows
the picture of colonial mentality.
The evidence of colonial mentality
are present in judiciary. The
decision of one pleads before
judge as a subject would during
colonial time. Subject are inferior.
The aggrieved behaviour as a subject
or inferior while the behaviour of
judge as a master. The words
used as terminologies of court
shows the same colonial
mentality. Like the words Your
Honour, My Lord, Your Excellency.
Even the application written
as a 'petition' for the dispensation
to judge. For instance the
Case of Malvi Tamizuddin
Dominion of Pakistan. in

which supreme court gave the decision in the favour of Chaudhry Ghulam Mustafa Khan and dismissed the 1st Constitution assembly which led the cause of Bangla separation. Moreover, the delayed the decision are honours and effect the progress of Pakistan. The judges take oath for the protection of legislation. But what is that happens during the regime of Zia (1979-1987) or General Musharraf (1999 to 2008). The Judge gave the decision of about Zulfikar Ali Bhutto. The Judges ^{as a result} continuing sole of our decision. The dealy ^{is} ashamed the sole of judiciary as the chronic time. The recent execution sole in accession. The martyr human imposed accusation and hanged in adyale jail. After her death the court gives the decision of his innocence and order

to release him. It showed the colonial mentality, and hindering Pakistan progress. Because public treats like a slave, and ruler as a master. The decision are made according to the master's interest. The public faces suffer for justice they do not get. Because it made according to interest of ruling elite.

The Feudalism also hindering the Pakistan progress it is the worst condition. The British gave his loyal supporters to estates as they follow their colonial government in the reward the support their tax collections agitation in population and deprived role of colonial master. They favoured the masters and ignored the public when masters are happy with their

Behaviour they provide them estates and also gives high position. Similarly, in this exa. the feudals are act as a master and public as a slaves and inferiors. They do not have right to take decision independently. They take decision seldom with the permission of lord. Similarly the maintenance of government. The successful government are formed with the support of these feudals. They control public and makes administration. where the public not have right of their own interest. in ruling area even people do not caste vote with their own will. The Ishrat Hussain BOOK "Pakistania hard country" in which he explain the worst condition of constitution in Pakistan. in rural area poverty, lack of

Education, lack of resources makes the condition worst and hindering Pakistan progress.

The colonial mentality is practice by rich country which imposed their holds in poor country. it is the brutal condition. The british take exploitation from the economy of Pakistan. According to the USA Pakistan a historian economist said British take 45 trillion dollars from sub-continent to england during colonial era. Similar they use their resources and tested their sources of Gold, silver, and other natural resource from their country. The british market new market in sub-continent for trade and transport resource from

their country. Moreover the digital encyclopedia showed that during colonial region 1834 to 1920 more 1720000 labour transferred to England. They worked without wages. It is the brutal condition that stopped the progress of country. In her book Home Country Pakistan: Global Politics, Ayesha Jalil write the doctrine Zulfikar Ali Bhutto which effect the Pakistan progress.
