IRSA: (Indus River System Authority)

Indus River System Authority (IRSA) is a water regulatory body in Pakistan, established in 1991. The authority was established for regulating and monitoring the distribution of water resources of the Indus River system among the provinces, in accordance with provisions of the water accord. It oversees the distribution of water seasonally. It is also responsible for the records of influx and outflux of water and also the consumption of water. It also decides the new hydro-projects in the country.

Members

IRSA consists of five members, appointed by the federal government of Pakistan.

Each member is typically a technical experts in water management or irrigation and is nominated by their respective provincial or federal government.

Decision Making

Ideally, IRSA decisions are made by consensus. If consensus is not possible, a majority vote (3 out of 5) decides the outcome.

In case of any disagreement by one or two members or any provincial assembly passed any resolution against decision, then Council of Common Interest (CCI) is responsible to resolve that issue. It consists of 7 members:

1. Prime Minister of Pakistan - Chairman
2. Four Chief Ministers of provinces
3. ^{Two} ~~Three~~ members from federal cabinet nominated by PM.

Venue: Cholistan region, Punjab on Sutlej river.

Objective

- Irrigate 1.2 million acres of barren land in Cholistan.
- Increase crops and livestock (Camels)

INDUS WATER TREATY (IWT)

The Indus Water Treaty (IWT) is a water-sharing agreement between Pakistan and India. It was signed in 1960 between Pakistan's President Ayub Khan and India's first Prime Minister Jawaharlal Nehru. The World Bank acts as Mediator and International Court of Arbitration as arbitration.

4. Division of Rivers

- The eastern rivers (Ravi, Beas, Sutlej) were given to India/Pakistan

- The Western rivers (Indus, Jhelum, Chenab) were given to Pakistan.

- India have rights to use western rivers but have conditions.

Conditions

- The need of water in Pakistan is less.

- Run of the river projects like Dams, tunneling.

- Can't divert the natural flow.

- India must approve the design of Dams by Pakistan.

- Pakistan have rights to appeal against Dam structure i.e. height of Project

→ Diversion of flow.

Permanent Commission

The treaty established the Permanent Indus Commission (PIC), with one commissioner from each country, to handle disputes and monitor the treaty's implementation.

Current Issue

Currently the issue is rising that the water level is decreasing regularly, as quoted by IWT, Asian Development Bank and World bank, that the flow of river decreased and also there is 50% cut each

In Jhelum and Indus River.

India's stand

- Climate change is major responsible
- Decrease in seasonal and monsoon rainfalls.
- The temporary snow deposits also declined.

Pakistan's stand

- Pakistan accepts 50% points of India but quoted not only 2nd major reasons.
- Rainfall is 23% of total contribution
- Melting of glaciers is major contributor (67%)
- More dams being built by India e.g., Kishan Ganga dam, Baglihar, Salal, Rattle etc
- The height of dams is more e.g., Kishanganga's height is 33 feet more from actual (~ ADB, WB)
- Diverted Natural flow of Wullar lake in occupied Kashmir

Solution

- Pakistan must increase its need, utilization and storage capacity.
- Increase Dams e.g., Diamer Bhasha Dam, Kalabagh, Dasu, Kohala, Pir Mehr ete
