Introduction

The establishment of BRICS group (that is Brazil, Russia, India and China) in September 2006, and its first Summit meeting in 2009, and with accession of South Africa in 2011 to become an entity that includes the fastest growing economies in the world.

The group was designed to bring together the world's most important developing countries, challenge the political and economic power of the wealthier nations of the North America, America and Western Europe. Egypt, Ethiopia, Iran, Saudi Arabia and the United Arab Emirates (UAE) were invited to become members with effect from 1 January 2024. However, Saudi Arabia's government minister said in mid of January it had not joined. Moreover, the group may change its group name to 'BRICS+'.

BRICS countries include major world powers, such as China and Russia, and countries which are influence on their region, such as South Africa and Brazil. The expanded group has a combined population of about 3.5 billion and combined

As the group with Iran, and Saudi Arabia and UAE as members, Brics countries produced almost 44.1% of the world crude oil. The group make their own bank which is known as Brics nations set up


the 'New Development Bank' to lend money to boost infrastructure.

By the end of 2022, it had provided nearly \$ 32bn to emerging nations for new roads and railway projects.

The States mostly used the U.S dollar for international trading between them. The politicians in Brazil and Russia have suggested that Brics should create a Brics currency to reduce the dollar's dominance and dependency. In future it is possible that they make a new currency to be used for international trade payments, or a cryptocurrency for international trade.

Membership in Brics would offer Pakistan closer ties to faster growing economies, facilitating trade, investment, technology transfer, and access to larger market. It will also help to take lending money from Brics banks for infrastructure development. Pakistan, disenchanted with Western-dominated financial institutions like the IMF or WB.

Pakistan, which serves an crucial role in international links like Belt and Road Initiative (BRI), notably investing in China-Pakistan Economic Corridor (CPEC), to enhance regional integration. Pakistan's possible inclusion in Brics Plus, known for its flexible cooperation, could facilitate multilateral collaboration due to its super strategic location which can benefit China, Russia, central Asia and Iran.

Moreover, the joining of the Brics can be beneficial for Pakistan and India specifically to revive the Regional Cooperation for Development, an international organization which is not working

Although Pakistan's economic progress is hampered by political instability, resulting in its 20th largest economy status and based on purchasing power parity (PPP) and 46th largest based on nominal GDP. Pakistan makes its economy in a better conditions and the normalizing the political instability for becoming the member of Brics group.

In the Conclusion, the Pakistan need to establish a National Stability Committee, which will address the political and economic Stability of Pakistan.
