Qno. 2 The creation of more provinces is a persistent demand from some circles in Pakistan. How do you see the creation of more provinces in Pak; as benefited or harmful for the people? Explain your views with solid justification.

ANSWER:

The debate on the creation of new provinces is as old as the country itself. It became all more pronounced in 1955 when Pakistan experimented with the notorious one unit scheme, wherein subnational identities were suppressed to create a semblance of stability in the newly-born nation. The provinces in the then West Pakistan (Punjab, Sindh + Balochistan + NW/F) were merged into a single province to counterbalance East Pakistan. This agitated the East Pakistan the most because it changed their demographic majority and Urdu was imposed on them, ignoring their majoritarian language (Bangla). This ultimately led to the secession of East Pakistan in 1971.

Recent Debates on Creation of New Provinces

If history is any guide, it shows that new provinces should not be created along ethnic and linguistic lines. Rather, on pure administrative grounds, the debate should initiate to retain the spirit of federation in the country. Thus, in federal scheme of things, sub-national identities should be promoted to ensure their participation as co-creators in good governance, along with the centre rather than merely as consumers. This collective sense of national ownership will ultimately foster unity in diversity.

Benefits of New Provinces

(1) To Right Size the Existing Units

Punjab is the largest province of Pakistan by population, which alone has more people than Sindh, KP, and Balochistan combined. It is even larger than around 20 countries. Thus, right sizing it would ensure administrative efficiency without triggering any ethnic sensitivities. ✓

(2) To Reduce Disparity among the Existing Units

Smaller provinces often feel underrepresented in parliamentary seats and policy-making.

A) On Political Front

Punjab alone has 173 seats in the National Assembly, while the combined total of Sindh, K.P. and Balochistan is 150. This is why political parties focus heavily on Punjab during election.

(B) On Economic Front

The lopsided economic distribution under the 7th NFC Award favors Punjab over all the other small provinces. Punjab receives 51.74% federal revenue. Whereas, the other three federating units only get 48.26% federal funds.

(C) On Social Front

Punjabi culture and Urdu language make smaller provinces feel culturally sidelined. Ethnic nationalist movements are gaining traction and call for greater provincial autonomy against an over-centralized system.

(3) Performance of Former Princely States

The sweeping statement against the formation of new provinces is this that they cannot perform better. A relevant case in point is Khairpur

(now part of Sindh). It generated significant revenue for the central government due to its relative political autonomy??

(4) Lessons from Developed Countries

In line with international best practices, creation of new provinces has gathered enough consensus. For instance, Turkey has 81 provinces despite the fact its population is almost two-thirds of Punjab's population alone while Pakistan has only four provinces.

(5) To Bridge the Core-Periphery Divide

Creating more provinces would bring the federating units closer to the capital. This will balance the power between the center (core) and marginalized regions (periphery).

(6) To Improve Grassroots Governance

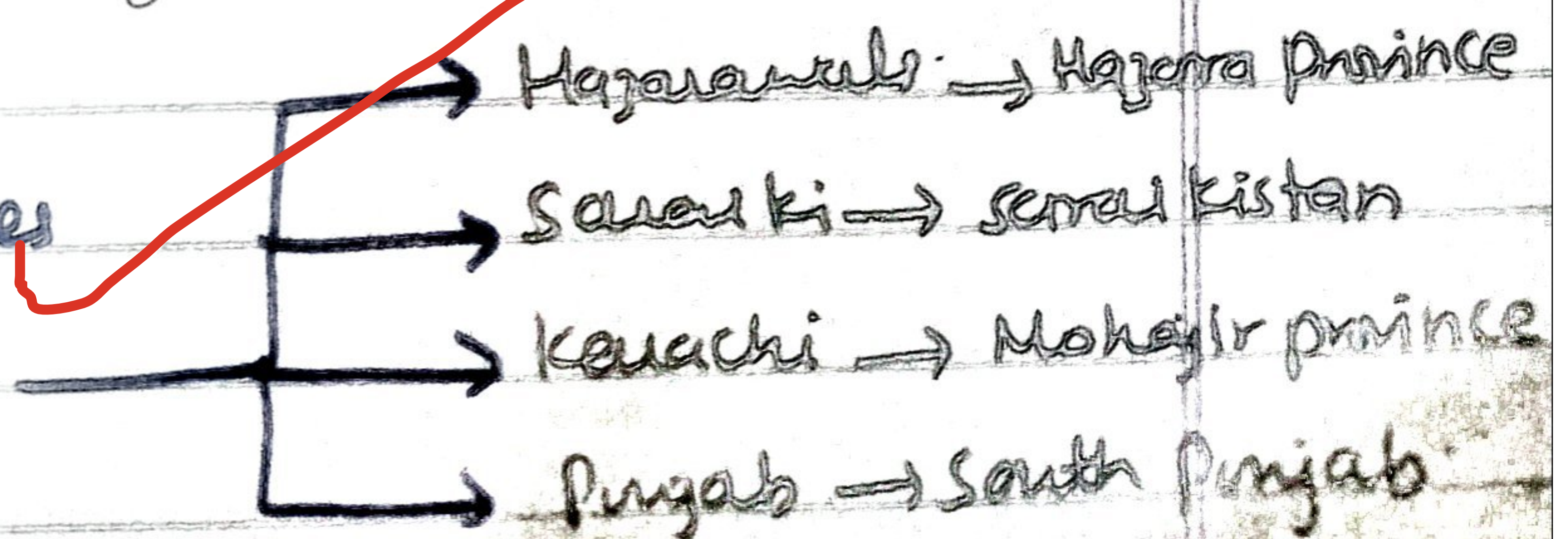
