Significance Of Shanghai Cooperation Organization (SCO) For Pakistan :

Pakistan became a full member in 2017, marking a milestone in its regional diplomacy. 1. Strategic Geographic Connectivity:-

Example:-

Gwadar Port offers landlocked Central Asian Republics access to the Arabian Sea, complementing SCO's connectivity vision.

2. Alignment With CPEC And Belt &

Road Initiative:

CPEC, Pakistan's flagship project under China's BRI, complements SCO's infrastructure agenda by enhancing transport, energy, and digital links.

Example:-

The 2024 SCO Summit in Islamabad promoted CPEC as a regional connectivity model.

3. Energy Security And Pipeline Projects:-

SCO includes energy-rich states like Russia, Kazakhstan, and Turkmenistan, offering Pakistan opportunities to meet its energy needs.

Example:-

Pakistan's engagement in the Turkmenistan - Afghanistan - Pakistan - India

(TAPI) gas pipeline discussions through SCO forums.

4. Counter Terrorism Collaboration:-

Through the Regional Anti-Terrorist Structure (RATS), SCO members coordinate intelligence and joint drills to counter extremism.

Example:-

Pakistan hosted the "PABBI Anti-Terror 2021" exercise with SCO partners to strengthen counter-terror capabilities.

5. Economic And Trade Expansion:-

SCO membership facilitates access to Central Asian markets for Pakistani goods like textiles, pharmaceuticals, and agricultural products.

Example:-

Pakistan signed trade agreements with Uzbekistan in 2021, expanding market access for rice and fabrics.

6. Diplomatic & Political Leverage:-

SCO membership boosts Pakistan's influence in shaping Eurasian

policies and balancing relations with global powers.

Example:-

Pakistan co-chaired the SCO Council of Foreign Ministers in 2023, pushing for consensus on Afghanistan.

7. Infrastructure Development Support:-

Through SCO cooperation, Pakistan can attract investment in large-scale infrastructure projects.

Example:-

China-funded Gwadar International Airport was inaugurated during the 2024 SCO summit.

8. Cultural & Academic Exchanges:-

SCO promotes cultural diplomacy and academic cooperation among member states.

Example:-

Pakistan hosted the SCO Youth Festival in Lahore to foster intercultural understanding.

9. Agricultural Cooperation:-

Membership provides opportunities for agricultural exports and knowledge exchange in farming technology.

Example:-

Pakistan's kinnor exports to Russia and Kazakhstan increased via SCO trade frameworks.

10. Support for Afghanistan Stability:-

SCO is a key platform for discussing and coordinating peace initiatives in Afghanistan, a direct security concern for Pakistan.

Example:-

Pakistan hosted high-level SCO meetings on Afghanistan after the US withdrawal in 2021.

Ideology Of Pakistan

Definition:-

Ideology of Pakistan refers to the guiding principles and beliefs on which the country was founded, rooted in the Two-Nation Theory. It holds that Muslims and Hindus of the subcontinent are two distinct nations, differing in religion, culture, history, and social values, and thus Muslims required a separate homeland to preserve their identity and live according to Islam.

Elucidation:-

The ideology of Pakistan is derived from Islam, which provides a complete code of life encompassing political, economic, social, and moral dimensions. It envisions a state where sovereignty belongs to Allah and governance is conducted according to the Qur'an and Sunnah, ensuring justice, equality, and the welfare of all citizens.

Historically, the ideology emerged as a political consciousness among Muslims

in India after the decline of Muslim rule and the rise of British colonial dominance. Religious differences, cultural distinctions, political marginalization, and economic backwardness reinforced Muslim nationalism. Leaders like Sir Syed Ahmad Khan, Allama Iqbal (Allahabad Address 1930), and Quaid-e-Azam Muhammad Ali Jinnah transformed this ideology into a concrete political demand, leading to the creation of Pakistan in 1947.

In essence, Pakistan's ideology is both a vision for statehood and a guiding principle for governance, aiming to preserve Islamic identity while ensuring justice, equality, and moral order in society.

Q:- Ideology of Pakistan In The light of speeches and statements of Allama Iqbal and Quaid-e-Azam.

Introduction:-

The ideology of Pakistan was shaped and articulated by visionary leaders, most notably Allama Iqbal and Quaid-e-Azam Muhammad Ali Jinnah. Through their speeches, writings, and political guidance, they provided philosophical and practical foundations for the creation of Pakistan.

2. Allama Iqbal's Vision:-

• Allahabad Address (1930):

"I would like to see the Punjab, North-West Frontier Province, Sindh and Balochistan amalgamated into a single State. Self-government within the British Empire, or without the British Empire, the formation of a consolidated North-West Indian Muslim State appears to me to be the final destiny of the Muslims."

- Emphasized Islam as a complete code of life and Muslims as a distinct political entity (Ummah).
- Warned that Hindu-majority rule would erode Muslim identity.

3. Quaid-e-Azam Political Articulation:-

Quaid-e-Azam transformed Iqbal's vision into a political movement.

• Lahore Resolution (1940):

Advocated sovereign

Muslim states to ensure cultural, religious, and political freedom.

- March 23rd, 1940 Speech:

"The Hindus and the Muslims belong to two different religious philosophies, social customs, and literatures. They neither intermarry nor inter-dine together and indeed they belong to two different civilizations."

- Repeatedly declared that Pakistan would be founded on Islamic principles of justice, equality, and fraternity.
- Address to the Constituent Assembly (11th August 1947): spoke on religious freedom, yet reaffirmed the guiding role of Islamic values in state affairs.

4. Ideological Convergence:-

- Iqbal provided the philosophical justification: Muslims are a separate nation and Islam is a complete way of life.
- Jinnah provided the political strategy: Mobilization of the Muslim League, negotiations, and constitutional measures to achieve statehood.
- Both leaders envisioned a homeland where Muslims could practice Islam freely and develop politically, economically, and socially in accordance with Islamic teachings.

Conclusion:-

The speeches and statements of Allama Iqbal and Quaid-e-Azam form the backbone of Pakistan's ideology. Iqbal's vision ignited the dream of a separate Muslim homeland, and Jinnah's leadership turned it into a political reality. Together, they ensured that Pakistan's creation was not merely a geographical division but the realization of an ideological aspiration rooted in Islam.

Q:- Downfall of Muslim Rule in the subcontinent.

Downfall Of Muslim Rule In The Subcontinent:-

Introduction:-

The Muslim rule in the Indian subcontinent, which began with the establishment of the Delhi Sultanate in 1206 and reached its zenith under the Mughals, gradually collapsed by the 18th century. Its decline was not the result of a single blow but rather a combination of internal decay and external pressures. A critical examination reveals political, military, economic, and socio-cultural factors that collectively

undermined Muslim power, paving the way for British colonial domination.

Major causes include:

• Internal Factors

1. Wars of Succession:

The Mughal Empire had no fixed law of succession. Whenever a ruler died, his sons and relatives fought bloody wars to claim the throne. These conflicts drained resources, weakened the central authority, and destroyed unity.

Example: After Aurangzeb's death in 1707, a long war of succession broke out between his sons, weakening the empire further.

2. Incompetent Successors Of Aurangzeb:

After Aurangzeb, the Mughal emperors were weak, pleasure-loving, and politically incapable. They failed to control provincial governors or defend the empire against internal and external threats.

Example: Bahadur Shah I and Farrukh Siyar lacked leadership skills and were easily influenced by court factions.

3. Internal Intrigues:

The Mughal court was plagued with conspiracies and factional politics among nobles, ministers, and royal family members. This created instability and reduced the efficiency of administration.

4. Moral Decadence Of Muslim Society:

Over time, the ruling elite became luxurious and morally corrupt. They lost the sense of discipline, justice, and service to the people, which had been the foundation of Mughal strength.

5. Financial Constraints:

Continuous wars, extravagant lifestyles, and declining agricultural productivity drained the imperial treasury. The inability to maintain the vast army and administration weakened Mughal power.

6. Demoralized And Inefficient Army:

The Mughal army, once a symbol of power, became outdated in tactics and weapons. Soldiers were demoralized due to irregular pay and corruption in the ranks.

7. Absence Of Naval Power:

The Mughals never developed a strong navy, making them vulnerable to European powers (like the British and Portuguese) who dominated the seas and controlled trade routes.

8. Rise Of Independent Dynasties:

Provincial governors and vassal states began declaring independence due to the central government's weakness. Example: Hyderabad, Bengal, and Awadh emerged as autonomous states.

9. Rise Of Marathas And Sikhs:

The Marathas in the Deccan and the Sikhs in Punjab grew stronger and constantly rebelled, challenging Mughal authority and further fragmenting the empire.

• External Factors

1. Incursion Of Nadir Shah:

In 1739, Nadir Shah of Persia invaded India, defeating the Mughal army and sacking Delhi. He looted immense wealth, including the Peacock Throne, and exposed the empire's vulnerability.

Ahmed Shah Abdali (Durrani) launched repeated invasions into North India between 1748 and 1767. His attacks caused massive destruction and instability in the empire.

Rise Of The British:

The British East India Company gradually expanded its control over Indian territories through superior naval power, modern military techniques, and political manipulation. The decline of Mughal authority created a vacuum that the British filled.
