Discuss the emergence of SCO and BRICS as a challenge to American politico-economic dominance in world politics. What measures can be taken by the U.S. to counter them.

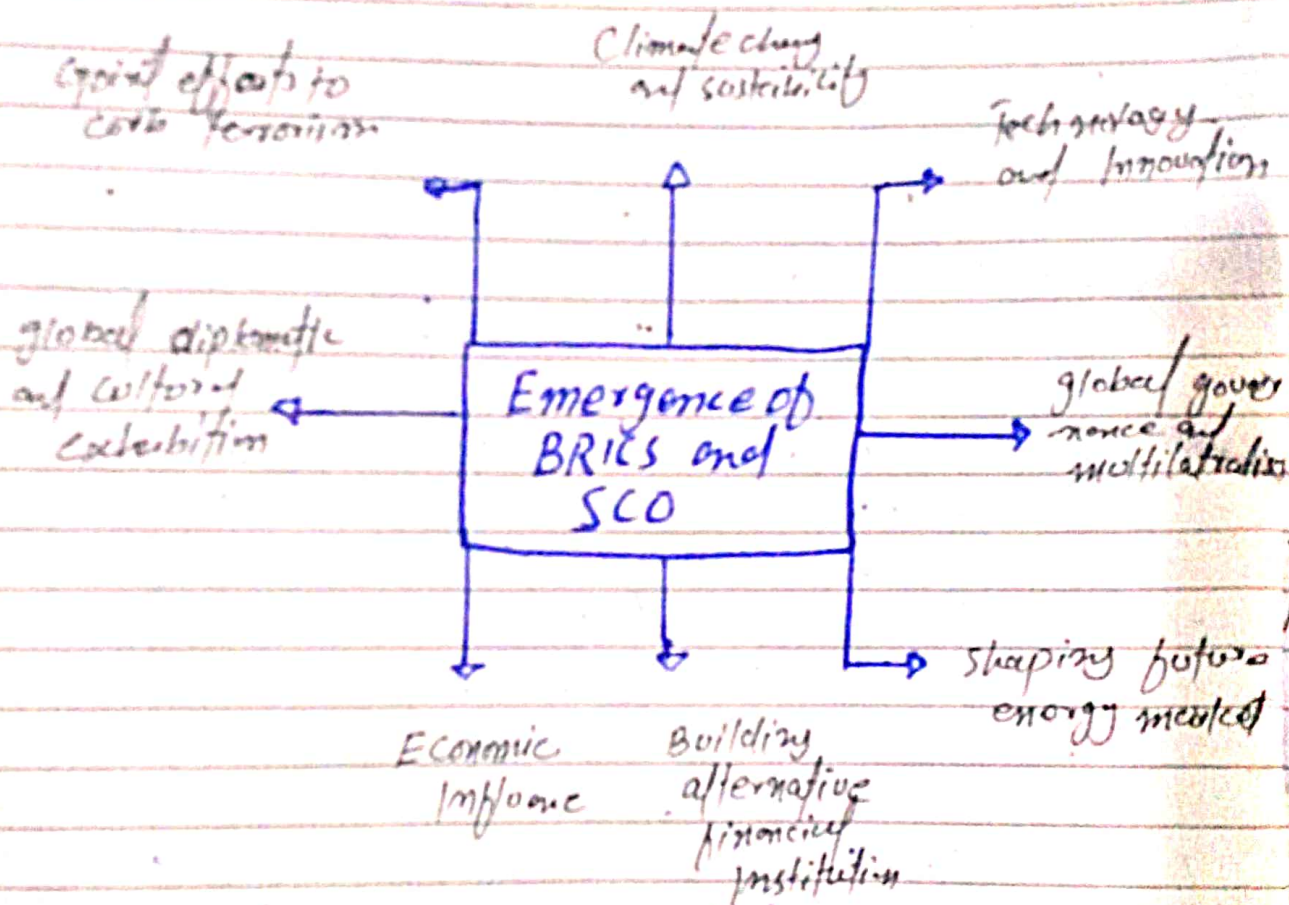
I. Introduction

i) Brics is not merely an emerging bloc, but a symbol of change in global Governance Narendra Modi.

The emergence of SCO and BRIC posed serious threat to the U.S. led world order. Their growing economic power in multiple arena has pushed the United States into isolation and economic slow down.

Furthermore, 3.5 billion or 45% world inhabitants and 29% of global GDP reserve BRICS while SCO hold 21% global GDP and significant landmass. Both these two blocs have significant impacts in global politics. For example, the three world super powers, include, China, Russia, India and hold significant portion of global economy. For instance, China is the world's fastest economy in the twenty-first century. And the bilateral trade between BRICS member countries are growing in a rapid pace.

3.5 billion or 45% of world population and 29% of global GDP. Furthermore, the bilateral trade volume between the United States and Russia reached \$190 billion.

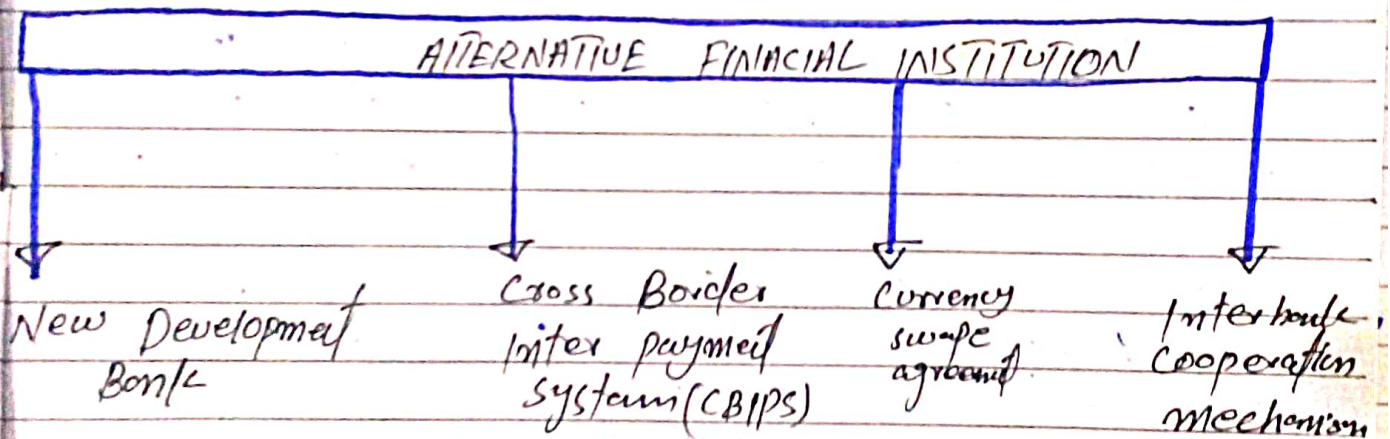

All BRICS member countries pledged to transform their economies towards renewable energy. Furthermore, in various climate initiative programs BRIC member countries take active parts.

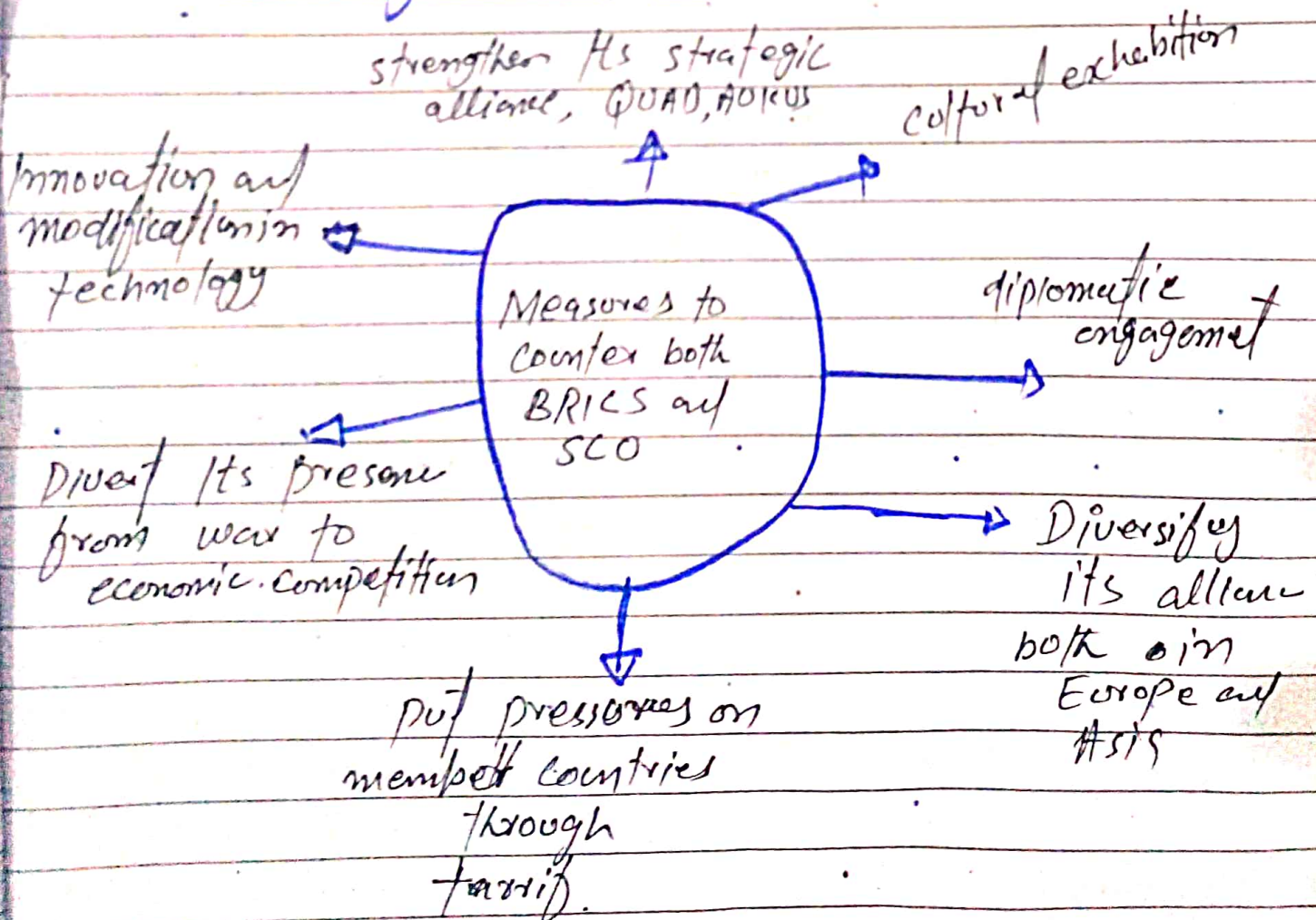
