Introduction:

Neuroscientists at Harvard discovered that 90% of a child's brain develops in the first 5 years, making these formative years the foundation of life. During these years, children absorb social, cognitive, and behavioral cues that shape both their own futures and those of generations to come. Their importance was recognized in particular by Friedrich Frobel, credited with founding kindergarten, who said, "play is the highest expression of human development in childhood", signalling that early education for children must be distinct and attuned to their developmental phases. Hence the field for Early Childhood Education (ECE) developed, which recognized the importance of an interactive, child-focused pedagogy. These frameworks nurture cognitive, physical, creative, social, and most critically, emotional skills. Children who are guided with love, taught positive coping mechanisms, and allowed to express themselves are likely to become individuals who can regulate their emotions and empathize with others. Hence, Early childhood Education, while instrumental in the intellectual and physical development of a child, plays a life-changing role in developing emotional intelligence, which in turn lays the foundation for a stable, tolerant, and progressive society.
