a, International Relations (Pre - 1919):

This phase is also termed as the philosophical phase. The key proponents in this time, the nation-state were Thucydides, Machiavelli, Thomas Hobbes and Kant. In this duration, IR was part of debates and discussions. Inculcated in Law, History, Philosophy but not an academic discipline.

b, International Relations in 1919:

It marked the end of World War 1. The politicians, state-actors came together to discuss the causes of the World War.

In the University of Wales, Aberystwyth, UK, first chaired by Woodrow Wilson. This is the foundation of International Relations. The agenda was to prevent further wars.

IR was a narrow scope at this time.

c, Second phase of International Relations (1920-1939):

This is marked as the first great debate era of International Relations. This was the time when two classical theories of IR with individual level of analysis formulated: Idealism Vs Classical Realism. The League of Nations provided the idealistic framework to prevent wars. The main proponent of Idealism was John Locke. However, the crisis termed the phenomenon as Utopian and called for a more realistic approach. The Idealism failed by the eruption of World War II. The realism dominated as according to realist Hans J. Morgenthau and Carr. It is power struggle and war is inevitable. Carr also wrote a book, 20 years of crisis, criticizing Idealism and calling for Realism.

d, Third phase of International Relations (1950's):

This era or phase is termed as the Behaviouralist era. In this no major theories emerged, but the approach and lens to study IR was transitioning from Philosophical to Scientific.

c, The era of 1960s - Third Great Debate and Structuralist, Positivist Approach:

The emergence of the Neo-Neo debate broke out in this era. The shift moved from individual level to state level. Majorly two debates ruled Neo-Realism and Neo-Liberalism. Neo-Realism focusing more on Power Politics and Neo-Liberalism on Co-operation and Peace. Immanuel Kant and Kenneth Waltz were the major proponents.

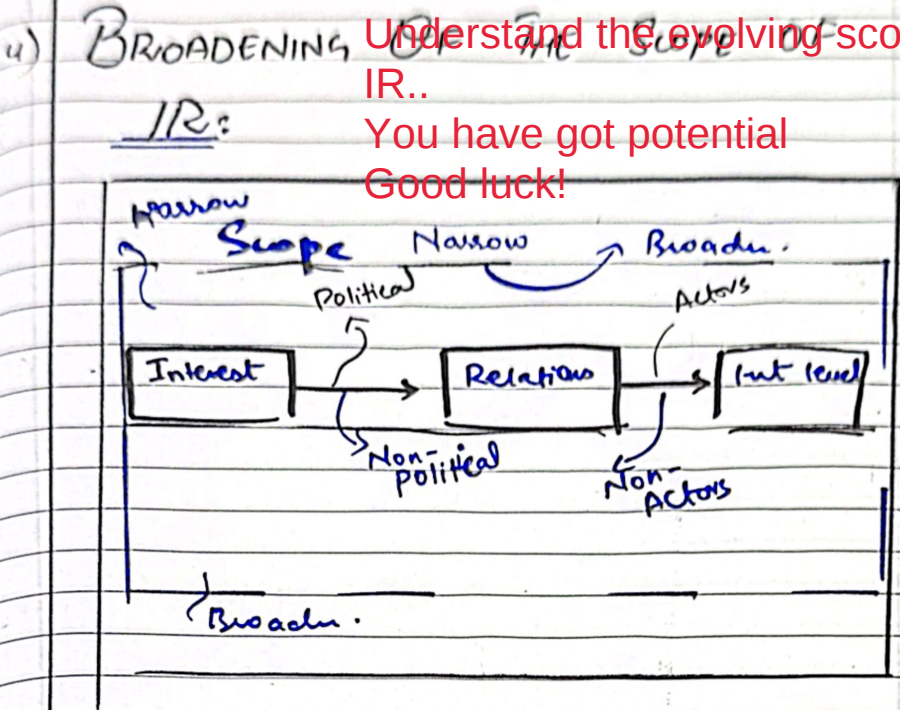
f, Current Era - Post Modernism
