

What is your position on the nature vs nurture debate in criminology?

Explanations

Criminology is the study of science of crime including, what leads towards crime, how the crime being committed and the impact inflicted on society by crime.

Nature vs nurture debate in criminology is supported by different biological and social organization theories. It arises a question that whether crime is committed because of some natural aspects in criminal or it is resulted in socio logical factors. Even though crime can not be committed solely by nature and by nurture. It posits that nature is nurtured to result in criminal activity.

A) Description of nature

Nature of criminal and crime is justified by criminal behaviour

theories. Classical school of criminology suggests that crime is a rational choice of individual.

In contrast, biological and psychological theories highlighted the natural trigger for criminal behavior. Nature is individual's natural capacity identified by physical or hormonal or psychological factors. These factors are naturally present and can not be changed.

b) Description of Nurture

Nurture is the favouring circumstances and environment of an individual which allows them to commit crime. Nurture has no link with natural aspects. An individual can leads criminality by learning crime by labelling by society, socio-economic factor or by environment. Crime can not be resulted solely by single factor, the environment flourishes the

mind and personality and restrain from non-criminal behaviour.

c) Support from Sociological theory

Sociological theory truly blames the sociological factors for criminal conduct. They emphasized on nurture by environment and socio-economic factors. It include relation with family, peers, community and education as contributing factors in early crime. According to Pakistan Journal of Criminology, the most of the juvenile delinquents have no education and drop out before primary education. Lack of education can nurture in criminality by ~~lack~~ bringing poverty. For instance, in case of Amir Qayyoom, Saifat Mirza, their environment including poverty and peers resulted in crime. Nature has no role there.

d) Stance of psychological theory

Psychological theory highlights

nature as responsible for crime

Some people have psychological issues, including brain damage which can cause fight between 'Id', 'Ego' and 'Superego' as explained by

Sigmund Freud. Such people can not create balance between 'Id' and 'Superego', their lack of 'Ego' contributes in crime. Although, it can be nurtured by physical or emotional trauma. But, usually it is natural phenomenon.

E) Learning Theory favors 'Nurture'

Learning theory by Edwin Sutherland in his book Principles of Criminology, supported the idea of learning crime. He posits that crime needs learning, it can not be done by properly without some guide. That's why professional thieves join gangs and learn crime from them. Nurturing pushes

the ability to commit crime. Sutherland focused on setups which inferred the criminal activities. He analysed that crime demands learning and natural ability to commit crime has no role in it. Crime is learned by any other skill. For instances, many militant groups train their special terrorists for special tasks, including, Lashkar Jhangvi, Haggani Network etc.

F) Perspective of Biological theory

This theory by all aspects from gene to physix, supported their perspective that crime is result of biological naturally occurring factors. Cesare Lombroso activist form declares physical characteristics of being a criminal. Lombroso shows that high cheek bones, sloping eyebrows, big ear, dark skin, prominent jaws etc are the physical characteristics.

for criminal. William Sheldon gave the concept of somatotypes such as ectomorphic, mesomorphic and endomorphic. He posits that mesophiles are more prone to be criminals. However, genes like MAOA, CDH-13 contributes in aggressive behavior by releasing chemicals in mind. Hormones like testosterone in males and females before moderation release hormone results in irrational or more aggressive behavior. These factors are natural and inclined a person towards crime. It is difficult to influence these by nurture.

(i) Solution by 'Social Control Theory'

Social control theory is given by Travis Hirschi and he guided the social control can limit criminal behavior. He analyzed all factors that can lead to

crime and concluded that by controlling some factors, crime can be restricted. He advised to build good relations with family, friend and in society. He focused that if a person has a lot to lose in result of crime, he will never prone to commit crime. The establishment of good social factors including employment can restrict crime as poverty is leading cause of crime specially.

Chief. Punjab university Department of Criminology report in 2018 presents the data of prisons in Punjab and explains that 41.1. criminals committed thief because of poverty. Poverty can lead to murder, burglary etc.

Although, nature plays role in committing crime but it has very less part. From jail data, 25.1. of criminals in jail are psychopath, even though they are only 1.1. of whole population. So, they

must be treated. The environment and socio-economic situation can restrict and contribute in criminality.

A good society and economic situation can restrict a psychopath from crime. Also, check by law can hinders in crime. Hence, nature can be nurtured in positive way and restrict from criminality.
