1 Introduction

Accountability is important to maintain equality and Justice in society. In Islam accountability means answerable to Allah for your actions, as well as before the individual and society. It is not for only specific community or class however it applies on everyone, regardless of class, status or race. Accountability is tested in every sphere including spiritual, social, political, economical and personal.

Importance of accountability in Islamic value system

Islamic values and teachings are based on the three core principles.

- ↳ Tauheed (Oneness of God)
- ↳ Adl (Justice)
- ↳ Khilafat (Vicegerency)

01) Tauheed (oneness of God)

Every muslim has a belief in tauheed that there is only one God who is running this entire world. Tauheed help individual to connected with Allah and make him remember that he is answerable for his actions to Allah. The one who belief in one God (Allah) alway remember that he is being watched by Allah and he has to answer to Allah for his good and evil deeds.

02) Adl (Justice)

Another important principle of islamic teaching is Justice. In Islam, Justice is mandatory for accountability. A person who maintain Justice in public and private life can ensure accountability.
